RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO NEGOTIATE AND ENTER INTO CONTRACTS NECESSARY FOR THE ACQUISITION OF A PORTION OF LOT 2, PLAN PSU-100282, SHO-20045, L.E. CASE NO. H-43, LRC RECORD NO. H-1005, SITUATED AT BARRIO OF SUPA, MUNICIPALITY OF TIGBAUAN WITH AN AREA OF TWO HUNDRED EIGHTY-TWO (282) SQUARE METERS, MORE OR LESS, WITH THE HEIRS OF CATALINO GARIBAY
