RESOLUTION CONFORMING AND APPROVING THE CY 2024 SUPPLEMENTAL BUDGET OF BARANGAYS, ATABAYAN, NAMOCON, 1 POBLACION, PARARA NORTE, BAYUCO, BANGKAL, BANTUD, BUENAVISTA AND LANAG, ALL OF THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on November 5, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization, the CY 2024 Supplemental Budget of the aforementioned Barangays, this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

The appropriation of Brgy. Atabayan for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P450,000.00 is for the Electricity Expense – P95,000.00, Training Expense – P45,000.00, Travelling Expenses - P20,000.00, CCTV Camera – P50,000.00, Street Light – P100,000.00, Monitoring Vehicle – P140,000.00, chargeable against CY 2022 & 2023 Retained Operating Surplus (PS & MOOE) and BDRRM Trust Fund CY 2021-2023;

The appropriation of Brgy. Namocon for Supplemental Budget No. 2024-001-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P80,000.00 is for the Travelling Expenses – P10,000.00, Electricity Expenses – P40,000.00, Training Expenses – P30,000.00, chargeable against CY 2021 Retained Operating Surplus- (PS and MOOE);

The appropriation of Brgy. 1 Poblacion for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P115,000.00 is for the Training Expenses- P70,000.00, Electricity Expenses – P15,000.00, Travelling Expenses - P20,000.00, Cultural Expenses – Other MOOE – P10,000.00, chargeable against CY 2021 Retained Operating Surplus (PS & MOOE);

The appropriation of Brgy. Parara Norte for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P295,000.00 is for the Travelling Expenses – P30,000.00, Training Expenses - P50,000.00, Office Supplies – P7,000.00, Electricity Expenses – P8,000.00, Disaster Response & Rescue Equipment – P200,000.00, chargeable against CY 2023 Retained Operating Surplus (PS & MOOE) and BDRRM Trust Fund from CY 2018-2021;

The appropriation of Brgy. Bayuco for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P75,000.00 is for the Travelling Expenses – P20,000.00, Training Expenses – P40,000.00, Electricity Expenses – P15,000.00, chargeable against CY 2023 Retained Operating Surplus;

The appropriation of Brgy. Bangkal for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P75,000.00 is for the Travelling Expenses- P17,000.00, Training Expenses – P50,000.00, and Electricity Expenses – P8,000.00, chargeable against the CY 2023 Retained Operating Surplus (PS and MOOE);

The appropriation of Brgy. Bantud for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P135,000.00 is for the Training Expenses – P40,000.00, Training Expenses – P65,000.00, Electricity Expenses – P25,000.00, Cultural Activity – other MOOE-P5,000.00, chargeable against Retained Operating Surplus (PS and MOOE);

The appropriation of Brgy. Buenavista for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P145,000.00 is for the Travelling Expenses – P25,000.00, Travelling Expenses – P25,500.00, Electricity Expenses – P50,000.00, Printer/Photocopier – P40,000.00, Statutory Obligations 10% SK Fund – P3,000.00 5% BDRRM Fund – P1,500.00 chargeable against CY 2022 Retained Operating Surplus (PS & MOOE);

The appropriation of Brgy. Lanag for Supplemental Budget No. 2024-001 001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P85,000.00 is for the Travelling Expenses – P20,000.00, Training Expenses – P60,000.00, R/M – Machinery & Equipment – P3,000.00 and Other MOOE – P2,000, chargeable against Retained Operating Surplus (PS & MOOE): CY 2021-P35,000.00, CY 2022 – P40,000.00, CY 2023 – 10,000.00;

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/Supplemental Budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
