RESOLUTION FOR THE REACTIVATION OF DORMANT GENERAL FUND WITH ACCOUNT NAME MUNICIPALITY OF TIGBAUAN WITH LANDBANK OF THE PHILIPPINES- ILOILO ( IZNART BRANCH) UNDER CURRENT ACCOUNT NUMBER 0032-1097-13 AND DESIGNATING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR AND ELMA G. TIONSAY, MUNICIPAL TREASURER AS OFFICIAL SIGNATORIES THEREOF

WHEREAS, said bank account had been the official depository for General Fund both for municipal collections and National Tax Allocation intended for the Municipality of Tigbauan;

WHEREAS, Sangguniang Bayan Resolution No. 2022-179 dated December 9, 2022 was passed granting authority to Atty. Virgilio T. Teruel, Municipal Mayor to open an account with Landbank of the Philippines- Plaza Libertad Branch for purpose of transferring the National Tax Allocation (NTA) share of the Municipality of Tigbauan from Landbank of the Philippines - Iloilo Branch to Landbank of the Philippines, Plaza Libertad Branch, Iloilo City;

WHEREAS, due to the transferring of account from LBP Iloilo located at Iznart St. Iloilo City to LBP Plaza Libertad Branch, transactions with the above mentioned account had been stopped for more than a year thereby rendering its status from active to dormant;
