RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO TRANSFER THE PROJECT-CONSTRUCTION OF FLOOD MITIGATING STRUCTURE-CONSTRUCTION OF SIBALOM RIVER FLOOD CONTROL PROJECT- FROM BARANGAY 8 POBLACION, TIGBAUAN, ILOILO TO BARANGAY TAN PAEL, TIGBAUAN, ILOILO DUE TO ADVERSE ISSUES CONCERNING RIGHT OF WAY.

WHEREAS, the construction of the Flood Mitigation Structure-Construction of Sibalom River Flood Control Project, Tigbauan, Iloilo was included in the Physical Status Report for CY 2023 and CY 2024 of projects being implemented by DPWH, Iloilo 1st District Engineering Office for the month of September 2024;

WHEREAS, unforeseen concerns arose during the preparation of documents for the implementation of the said project in Barangay 8 Poblacion, Tigbauan, Iloilo;
