RESOLUTION ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECUTIVE COMMITTEE (EXECOM) RESOLUTION NO. 2024-05, DATED NOVEMBER 14, 2024, “RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) CY 2024 FOR THE PAYMENT OF TRANSFER TAX FOR LAND PURCHASED CHARGEABLE AGAINST THE CONTINUING APPROPRIATIONS-EXECUTIVE SERVICES-OTHER INFRASTRUCTURE ASSETS IN THE AMOUNT OF TWO HUNDRED THREE THOUSAND EIGHT HUNDRED SIXTY-EIGHT PESOS (P203,868.00) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”

WHEREAS, in a letter dated November 15, 2024, the Local Chief Executive requested this August Body for the URGENT passing of the aforementioned Resolution;

WHEREAS, Section 305 (a) of R.A. 7160 or the Local Government Code of 1991 provides that, “No money shall be paid out of the local treasury except in pursuance of an appropriations ordinance or law”, Hence, it necessitates the passing of an ordinance before the LGU-Tigbauan can validly utilize the abovementioned supplemental budget;

WHEREAS, there is a need for the payment of Transfer Tax for Land purchased intended for the new Government Center in the amount of Two Hundred Three Thousand Eight Hundred Sixty-Eight Pesos (P203,868.00);
