RESOLUTION CONFORMING AND APPROVING THE CY 2024 SUPPLEMENTAL BUDGET OF BARANGAYS, CANSILAYAN, BUGASONGAN, 4 POBLACION, LUBOG AND LINOBAYAN, ALL OF THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on November 20, 2024 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization, the CY 2024 Supplemental Budget of the aforementioned Barangays, this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

*The appropriation of Brgy. Bugasongan for Supplemental Budget No. 2024-001-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P130,000.00 is for the Travelling Expense - P50,000.00, Training Expense - P60,000.00, Electricity Expense - P20,000.00, chargeable against CY 2022 Retained Operating Surplus (MOOE) - P130,000.00;*

*The appropriation of Brgy. 4 Poblacion for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P170,000.00 is for the Training Expense- P30,000.00, Training Expense - P80,000.00, Electricity Expense - P60,000.00, chargeable against CY 2022 Retained Operating Surplus (MOOE) P170,000.00;*

*The appropriation of Brgy. Lubog for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P50,000.00 is for the Travelling Expense - P35,000.00, Training Expense - P10,000.00, MOOE-Other MOOE- P5,000.00, Chargeable against CY 2022 Retained Operating Surplus (PS & MOOE)- P50,000.00;*

*The appropriation of Brgy. Linobayan for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P125,000.00 is for the Travelling Expense - P35,000.00, Training*

Expense - P30,000.00, Electricity Expense - P30,000.00, MOOE-Other MOOE- P5,000.00, Capital Outlay - Office Equipment - P25,000.00, Chargeable against CY 2022 Retained Operating Surplus (PS & MOOE)- P125,000.00;

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/Supplemental Budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
