RESOLUTION EARNESTLY REQUESTING ONE (1) UNIT FIRE TRUCK FROM THE OFFICE OF HON. FERDINAND MARTIN G. ROMUALDEZ, SPEAKER OF THE HOUSE OF REPRESENTATIVES, FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991, states that *“every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, the Municipality of Tigbauan is one of the seven (7) towns of the First Congressional District of the Province of Iloilo with 52 barangays and has about 65,245 population, more or less, as of the latest Philippine Statistics Authority census;

WHEREAS, the Bureau of Fire Protection (BFP)-Tigbauan has recorded a total of twenty four (24) fire incidents in the municipality from January 2024 up to the present which affected an alarming number of families and households;

WHEREAS, the Local Government Unit of Tigbauan is concerned of the increasing number of fire incidents within its jurisdiction and believes that the provision of one (1) unit fire truck enhances the efficiency and responsiveness of the municipality in the response of fire incidents in the locality;

WHEREAS, the Local Government Unit of Tigbauan believes that through the benevolence of Hon. Ferdinand Martin G. Romualdez, Speaker of the House Of Representatives, the provision of one (1) Unit Fire Truck can be of great help for the municipality in the delivery of its basic services relative to the protection of life and property;
