RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DEPED), DIVISION OF ILOILO FOR THE **ESTABLISHMENT OF CANABUAN ELEMENTARY SCHOOL**, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated November 28, 2024 requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Granting Authority To Atty. Virgilio T. Teruel, Municipal Mayor, For And In Behalf Of The Municipality Of Tigbauan To Sign And Enter Into A Memorandum Of Agreement (MOA) With The Department Of Education (DEPED) Division of Iloilo for the Establishment of Canabuan Elementary School;”*

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **DepEd Division of Iloilo**, a government office under the Department of Education (DepEd), with principal office at Luna St., La Paz, Iloilo City, represented herein by its Schools Division Superintendent, **DR. ERNESTO S. SERVILLON, JR., MNSA, CESO VI**, hereinafter referred to as **“DepEd”**; and
- The **Municipality of Tigbauan**, a Local Government Unit created under the Phillipine laws, with principal office at Barangay 9 Poblacion, Tigbauan, Iloilo, represented by its Municipal Mayor, **Atty. Virgilio T. Teruel**, hereinafter referred to as **“LGU”**.

WHEREAS, the DepEd Division of Iloilo is in need of additional elementary school, particularly within the catchment area of the Municipality of Tigbauan, to accommodate 164 or more prospective enrollees;

WHEREAS, the establishment of the proposed CANABUAN ELEMENTARY SCHOOL is considered an urgent need in the LGU as indicated in the proposed feasibility study;

WHEREAS, the LGU agrees to be a counterpart of DepEd in the establishment of the proposed school;

WHEREAS, for and in consideration of the terms and conditions set forth below, the parties hereby agree to the following provisions:

1. **ROLES AND RESPONSIBILITIES OF DEPED**

1.1 The DepEd shall ensure the issuance of DepEd School ID in the name of CANABUAN ELEMENTARY SCHOOL;
The DepEd shall spearhead the implementation of the school's education curriculum;

1.2 The DepEd shall work for the school's funding requirements for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay in the General Appropriations Act, and the subsequent issuance of Agency Code;

1.3 The DepEd shall request for the creation of vital positions, both teaching and non-teaching, to the Department of Budget and Management (DBM), through the DepEd Regional and Central Offices;

1.4 The DepEd shall ensure the designation of an Officer-in-Charge of CANABUAN ELEMENTARY SCHOOL, and eventually the appointment of a school head who possesses the necessary qualifications pursuant to DepEd, DBM and CSC applicable rules and regulations; and

1.5 The DepEd shall monitor the operation of CANABUAN ELEMENTARY SCHOOL.
2. **ROLES AND RESPONSIBILITIES OF THE LGU**

2.1 The LGU shall provide financial assistance to CANABUAN ELEMENTARY SCHOOL through the Special Education Fund (SEF).
3. **OTHER CONDITIONS OF THE MOA**

3.1 This MOA does not in any way prevent the parties from entering into other stipulations as may hereafter be agreed to by the said parties; and

3.2 No part or portion of this MOA shall be amended or modified without the written approval of the parties hereto.

CAMPOSAGRADO, Committee Chairman) and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Florence Joy Cabalonga,

RESOLVED, to grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Sign and Enter Into a Memorandum of Agreement (MOA) With the Department of Education (DepEd) Division of Iloilo for the **Establishment of Canabuan Elementary School**, Municipality of Tigbauan, Province of Iloilo;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to Canabuan Elementary School thru Teacher-in-Charge, Ms. Estrella T. Endriga and to all concerned for their information and/or appropriate action.
