**Resolution No. 2024-188**

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO SIGN THE SUBDIVISION AGREEMENTS AND SUBDIVISION PLANS OF LOTS NOS. 10268-B2, 10268-B3, 10268-B4 AND 10268-B5 LOCATED AT BARANGAY DAPDAP, TIGBAUAN, ILOILO IN CONNECTION WITH THE LOT **TITLING OF DAPDAP NATIONAL HIGH SCHOOL.**

WHEREAS, Ms. Catalina Opuan a native of Barangay Dapdap, Tigbauan, Iloilo owned a parcel of Lot No. 10268 with an area of 52,170 square meters more or less located on said barangay;

WHEREAS, for her love and affection to Dapdap Barangay High School and Barangay Dapdap Health Center, she donated a portion of said lot with an area of 488 square meters to Brgy. Dapdap Health Center and the remaining portion with an area of 51,682 square meters to Dapdap Barangay High School thru a Deed of Donation executed last August 21, 1987;

WHEREAS, Tax Declaration No. 40-0031-00502 issued by the Assessor’s Office thru Mrs. Jonalyn Tirasol certified that Lot No. 10268-B with an area of 51,682 square meters was owned by Dapdap Barangay High School;

WHEREAS, Subdivision Agreements and Subdivision Plans were made in order to establish the actual portion of the municipal road network encroaching the said Lot No. 10268-B;

WHEREAS, it has been established that the total area of 588 square meters which was apportioned to the municipal roads such as: *10268-2B with an area of 197 sq.m.; 10268-3B with an area of 374 sq.m.; 10268-4B with an area of 14 sq. m. and 10268-5B with an area of 3 sq.m.* shall be donated to the Municipality of Tigbauan;

WHEREAS, the total area of 51,094 square meters will be the portion that Dapdap Barangay High School is going to apply for land titling;

NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA, Member, Committee on Education, Tourism and Civil Service (*under the authorship of HON. ADRIAN S. CAMPOSAGRADO, Committee Chairman*) and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Florence Joy Cabalonga,

Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan, to Sign the Subdivision Agreements and Subdivision Plans of Lots Nos. 10268-B2, 10268-B3, 10268-B4 and 10268-B5 Located at Barangay Dapdap, Tigbauan, Iloilo in Connection With the Lot Titling of Dapdap National High School;
