RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY BUYU-AN ORDINANCE NO. 07-2024 ENTITLED, “AN ORDINANCE DECLARING THE “PATIKAN” AS A FESTIVAL TO BE HELD EVERY 27TH DAY OF DECEMBER AT BARANGAY BUYU-AN, TIGBAUAN, ILOILO”

WHEREAS, Barangay Buyu-an Ordinance No. 07-2024 entitled, “An Ordinance Declaring the “Patikan” as a Festival to be held Every 27th Day of December at Barangay Buyu-an, Tigbauan, Iloilo” was adopted and approved by the Sangguniang Barangay last November 16, 2024 and was presented in a General Assembly last November 3, 2024;

WHEREAS, Barangay Buyu-an Ordinance No. 07-2024 was endorsed to the Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda, MLGOO VI on November 27, 2024;

WHEREAS, on December 4, 2024 during the Sangguniang Bayan of Tigbauan Regular Session, Barangay Buyu-an Ordinance No. 07-2024 was referred to the Committee on Rules, Ordinances, Resolutions and Legal Matters for review and recommendations;

WHEREAS, upon review, said ordinance is found consistent with the provisions of Section 391 of the Local Government Code, to wit:

“SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

1. Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (7) Regulate the use of multi-purpose halls, multi-purpose pavements, grains or copra dryers, patios and other post-harvest facilities, Barangay waterworks, Barangay markets, parking areas of other similar facilities constructed with government funds within the jurisdiction of the Barangay and charge reasonable fees for the use thereof;
- (14)Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;
- (24)Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;

WHEREAS, said Ordinance is also found consistent with SECTION 16 of the Local Government Code which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare;

WHEREAS, the Local Government Code further provides that local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants within their respective territorial jurisdictions.
