RESOLUTION TEMPORARILY AMENDING RULE VII, SECTION 14(b) OF RESOLUTION NO. 2022-083 OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE SCHEDULE OF THE **53RD REGULAR SESSION TO TUESDAY, DECEMBER 17, 2024**, AT 9:00 O’CLOCK IN THE MORNING.

WHEREAS, Rule VII, Section 14 par (b) of Resolution No. 2022-083 provides:

“RULE VII – REGULAR AND SPECIAL SESSIONS

Section 14. REGULAR SESSION

*(b.)The regular session shall be held every **Wednesday** and shall **start promptly at 9:00 in the morning**. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.*

WHEREAS, December 18, 2024 is declared as “Graciano Lopez Jaena Day”, Special Non-Working Holiday in the Province of Iloilo;

WHEREAS, due to the scheduled Capacity Development and Year-End Assessment of LGU-Tigbauan in Boracay, Malay, Aklan on December 19-21, 2024, the Sangguniang Bayan will not be able to conduct such session on the next working day following said holiday;
