RESOLUTION ADOPTING THE MUNICIPAL PEACE AND ORDER COUNCIL RESOLUTION NO. 2024-008 ENTITLED, “A RESOLUTION REQUESTING ONE (1) UNIT FIRE TRUCK FROM HON. JUANITO VICTOR “JONVIC” C. REMULLA, JR., SECRETARY OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT, FOR THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”

WHEREAS, in a letter dated December 6, 2024, the Local Chief Executive requested for the URGENT passing of the aforesaid resolution;

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991, states that *“every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, the Municipality of Tigbauan is one of the seven (7) towns of the First Congressional District of the Province of Iloilo with 52 barangays and has about 65,245 population, more or less, as of the latest Philippine Statistics Authority census;

WHEREAS, the Bureau of Fire Protection (BFP)-Tigbauan has recorded a total of twenty four (24) fire incidents in the municipality from January 2024 up to the present which affected an alarming number of families and households;

WHEREAS, relative to the fire incidents in the municipality, the Municipal Peace and Order Council (MPOC) passed a resolution on November 29, 2024 requesting for one (1) unit fire truck from DILG Secretary Juanito Victor “Jonvic” C. Remulla, Jr. to augment the existing fire trucks of the municipality for the efficient emergency response to fire incidents in the locality;

WHEREAS, the Local Government Unit of Tigbauan believes that through the benevolence Hon. Juanito Victor “Jonvic” C. Remulla, Jr., Secretary of the Department of Interior and Local Government, the provision of one (1) Unit Fire Truck can be of great help in the delivery of its basic services relative to the protection of life and property;
