Resolution No. 2024-200

RESOLUTION ADOPTING/APPROVING THE COMPREHENSIVE DRAINAGE PLAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 16 of RA 7160 or the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the local government of the Municipality of Tigbauan recognizes the importance of an efficient and sustainable drainage system to address issues related to flooding, water logging and the overall health and safety of its residents;

WHEREAS, the Office of the Municipal Engineer in consultation with relevant stakeholders, has formulated a Comprehensive Drainage Plan to improve the municipality’s drainage infrastructure and ensure effective management of storm water runoff, waste water and other related concerns;

WHEREAS, the plan includes provisions for the design, construction and maintenance of drainage systems as well as provisions for flood risk management, water quality improvement and environment sustainability;

WHEREAS, the adoption of the Comprehensive Drainage Plan will ensure the long term development and enhancement of the municipality’s drainage infrastructure and is in line with the goals of sustainable urban planning and climate-resilient development;
