RESOLUTION NO. 2024- 203

RESOLUTION APPROVING AND ADOPTING THE 2025 ANNUAL OPERATIONAL PLAN (AOP) OF THE TIGBAUAN MUNICIPAL HEALTH AND BIRTHING CENTER, TIGBAUAN, ILOILO

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health, and social services available to all people at affordable cost;

WHEREAS, Section 17(b)(2) of Republic Act 7160, otherwise known as the “Local Government Code of 1991” provides for the role of municipalities in the promotion of basic health services and facilities which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services, access to secondary and tertiary health services, purchase of medicines, medical supplies, and equipment needed to carry out said services;

WHEREAS, the Annual Operational Plan (AOP) for 2025, formulated and prepared by the Tigbauan Municipal Health and Birthing Center outlines the health initiatives, projects and activities that will be implemented in the municipality;

WHEREAS, the objectives of the Annual Operational Plan (AOP) 2025 is to guarantee the general well-being of the people of Tigbauan, promote maternity and child health, and improve the delivery of basic health services in the municipality;

WHEREAS, the Sanggunian Bayan of Tigbauan finds the significance of adopting the said plan for the successful implementation and attainment of the health objectives of the municipality;
