Dapdap for Supplemental Budget No. 2024-001 embodying Appropriation Ordinance No. 2024-001 - in the amount of P125,000.00 is for the Travelling Expense- P25,000.00, Training Expense – P70,000.00, Office Supplies Expense – P 10,000.00, Electricity Expense – P15,000.00, MOOE-Other MOOE – P5,000.00, chargeable against CY 2022 Retained Operating Surplus (MOOE) and for Supplemental Budget No. 2024-002 embodying Appropriation Ordinance No. 2024-002- in the amount of P12,100.00 is for the Grant of Service Recognition Incentive (SRI) chargeable against CY 2024 PS Savings;.
