RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH 1LIFE INC. IN CONNECTION WITH THE PROVISION OF MATERNAL, CHILD CARE, AND BIRTHING SERVICES IN COLLABORATION WITH THE TIGBAUAN PRIMARY CARE FACILITY.

WHEREAS, the Local Chief Executive in a letter dated September 2, 2025 requested this Sangguniang Bayan for an URGENT passing of a "Resolution Granting Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan, to Enter Into A Memorandum of Agreement (MOA) With 1life Inc. in Connection With the Provision of Maternal, Child Care, and Birthing Services in Collaboration With the Tigbauan Primary Care Facility;"

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- **1LIFE INC.**, a corporation duly organized and existing under Philippine laws with principal address at 83 Felix Manalo St. Cubao, Quezon City, with Primary Care Facility located at J.C. Zulueta St., Brgy. Poblacion South, Oton, Iloilo represented by its Medical Director Matt Jason J. Navarro; and
- **Tigbauan Primary Care Facility**, a duly recognized public health facility located at Brgy. 9 Tigbauan, Iloilo, represented by its Municipal Mayor, Atty. Virgilio T. Teruel, referred to as Primary Care Facility.

WHEREAS, 1LIFE INC., is a private primary care facility, offering preventive, promotive, and diagnostic healthcare services to patients in Oton and neighboring municipalities;

WHEREAS, the Tigbauan Primary Care Facility is engaged in the delivery of maternal and child care, and birthing services under the terms and conditions set forth herein;

WHEREAS, for and in consideration of the foregoing premises, the parties agree as follows:

OBLIGATIONS OF THE TIGBAUAN PRIMARY CARE FACILITY:

1. *Disclose to 1LIFE INC. its operating schedule, available services, and pricing.*
2. *Accept patients referred by 1LIFE INC.*
3. *Coordinate the 1LIFE INC. regarding the transfer of pregnant clients for delivery, including providing necessary medical records.*
4. *Submit a monthly report of patients catered to as referred by 1LIFE INC., for medical records purposes only.*
5. *Provide 1LIFE INC. with patient information, progress notes, and treatment plans as part of 1LIFE INC.'s records.*
6. *Maintain high standards of care for all maternal, child, and birthing services.*
7. *Inform 1LIFE INC. in writing at least fifteen (15) days prior to implementing any change in operating schedule or pricing.*
8. *Be responsible for informing, billing, and charging patients referred by 1LIFE INC.*

OBLIGATIONS OF ILIFE INC.:

1. *Refer patients needing high-risk maternal and child care, as well as patients requiring immediate birthing services, to the Tigbauan Primary Care Facility.*
2. *Provide the Tigbauan Care Facility with the necessary medical records of clients, including prenatal check-ups, laboratory tests, and other relevant information.*
3. *Coordinate with the Tigbauan Primary Care Facility regarding patient transfers for delivery.*
4. *Retrieve from the Tigbauan Primary Care Facility the records of patients catered to as referred by 1LIFE INC.*
5. *Ensure confidentiality of patient information and medical records provided by the Tigbauan Primary Care Facility.*

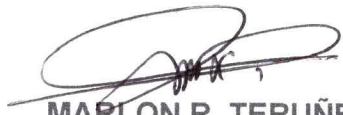
