**Resolution No. 2025-158**

**RESOLUTION EXPRESSING SUPPORT AND NO OBJECTION TO THE 200MW WIND POWER PROJECT OF GUIMBAL WIND ENERGY CORPORATION IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE ILOILO**

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers every local government unit to promote the general welfare, including the right of the people to a balanced ecology, sustainable development, and economic prosperity;

WHEREAS, Section 2, Article XII of the 1987 Philippine Constitution recognizes the role of the State in promoting sustainable energy sources by encouraging exploration, development, and utilization of natural resources, including renewable energy, for the benefit of the Filipino people;

WHEREAS, Republic Act No. 9513, otherwise known as the “Renewable Energy Act of 2008” declares it the policy of the State to accelerate the exploration and development and increase the utilization of renewable energy resources to reduce the country's dependence on fossil fuels;

WHEREAS, the Department of Energy (DOE), under Wind Energy Service Contract (WESC) No. 2023-04-276, has granted Guimbal Wind Energy Corporation (GWEC) the authority to explore, develop, and utilize wind energy resources within the municipalities of Guimbal, Miagao, Igbaras, Tubungan, and Tigbauan, Iloilo;

WHEREAS, GWEC intends to establish a 200 MW Wind Power Project that will provide clean and renewable energy, support the national thrust for sustainable energy development, and generate employment and economic opportunities for the Municipality of Tigbauan and its neighboring localities;

WHEREAS, in a letter dated August 1, 2025, Mr. Eric P. Bolo, Authorized Representative of GWEC, formally requested the Sangguniang Bayan of Tigbauan, for the issuance of a Resolution of Support and No Objection to their proposed project;

WHEREAS, in a letter dated August 15, 2025, Hon. Virgilio T. Teruel, Municipal Mayor, this municipality, endorsed to the Sangguniang Bayan the said request of GWEC for its favorable consideration;

WHEREAS, the Sangguniang Bayan of Tigbauan, after due consultations and consideration of the merits of the project, finds that the proposal is aligned with the Municipality's development objectives, provided that GWEC shall comply with all applicable national and local laws, environmental regulations, and social safeguards;

NOW, THEREFORE, on motion of HON. REYNALDO E. TUMABOTABO, Chairman, Committee on Information Communication Technology (ICT), Water and Energy, and duly seconded by Hon. Pinky T. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan of Tigbauan, Iloilo, to Express Support and No Objection to the 200MW Wind Power Project of Guimbal Wind Energy Corporation in the Municipality of Tigbauan, Province Iloilo;

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to the Energy Efficiency and Conservation Office (EECO) and to the Guimbal Wind Energy Corporation (GWEC) for their information and appropriate action.
