

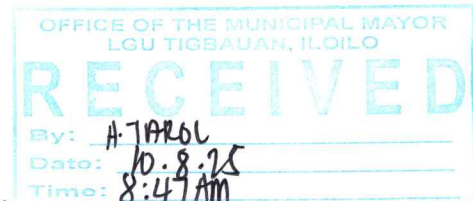

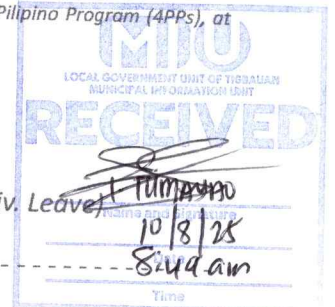

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT FINANCIAL ASSISTANCE TO YOUTH SOCIAL DEVELOPMENT LEADERS IN THE MUNICIPALITY OF TIGBAUAN IN THE AMOUNT OF FIFTY THOUSAND (P50,000.00) PESOS, CHARGEABLE AGAINST MSWDO-TRAINING EXPENSES

WHEREAS, pursuant to Article 14, Section 1 of the 1987 Philippine Constitution, stipulates for the protection and promotion of the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, further, paragraph (3) of Section 2, Article 14, of the aforesaid Philippine Constitution also stipulates for the establishment and maintenance of a system of scholarship grant, student loan programs, subsidies, and other incentives which shall be available to deserving students in both public and private schools specially to the under-privileged;

WHEREAS, the cost of learning for students includes the following, but not limited to: tuition fee, miscellaneous fee, laboratory fee, books and other learning materials, school supplies, internet connection load and photocopies of other school related works;

WHEREAS, the criteria for the beneficiaries are as follows: (1) The students must be a resident of the Municipality of Tigbauan, (2) The student must be currently enrolled in College or University; (3) The student must have no failed grade in all subjects and active PYAP members;

WHEREAS, this program will provide educational assistance to ten (10) unprivileged but deserving students in the amount of Five Thousand Pesos (P5,000.00) each to be able to stay in school to complete their studies and rise above their beginning as well as to become responsible citizens of the society;

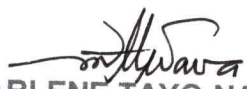
