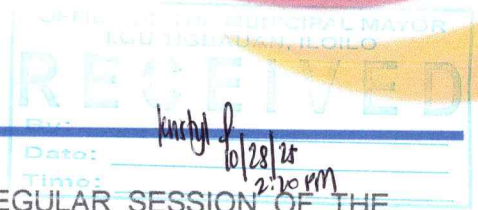

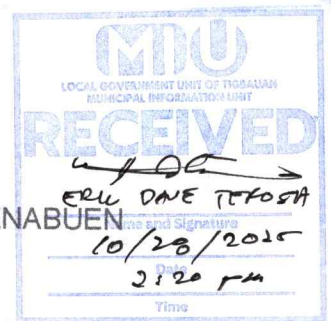

RESOLUTION CONFORMING AND APPROVING THE CY 2025 SK ANNUAL BUDGET OF BARANGAY LINOBAYAN, MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, the Municipal Budget Officer of Tigbauan, Iloilo, endorsed to the Sangguniang Bayan on October 7, 2025, the Calendar Year (CY) 2025 SK Annual Budget of Barangay Linobayan, as duly approved by the Sangguniang Kabataan, for review and appropriate legislative action;

WHEREAS, the SK Annual Budget of Barangay Linobayan in the amount of Two Hundred Seventy-One Thousand Pesos (₱271,000.00) shall be utilized for the following programs: 1) *General Administrative Program in the amount of One Hundred Sixty-Nine Thousand Pesos (₱169,000.00);* and 2) *SK Development and Empowerment Program in the amount of One Hundred Two Thousand Pesos (₱102,000.00);*

WHEREAS, the Municipal Budget Officer, after review, found the said SK budget to be compliant with the provisions of the Local Government Code of 1991 (RA 7160) and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the duty of the concerned barangay and SK officials to ensure the lawful, efficient, and proper implementation of the approved budget in accordance with existing laws and regulations;

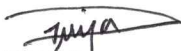
