RESOLUTION CONGRATULATING AND COMMENDING MS. LESLIE KATE TEJERO MACALING OF BARANGAY ATABAYAN, TIGBAUAN, ILOILO FOR PLACING TOP EIGHT (8) IN THE OCTOBER 2025 FISHERIES PROFESSIONAL LICENSURE EXAMINATION

WHEREAS, Section 9 (h) of Republic Act No. 8981, known as the “PRC Modernization Act of 2000” empowers the Professional Regulatory Boards to prepare, adopt and issue the syllabi or tables of specifications of the subjects for examination in consultation with the academe, and determine and prepare the questions for the licensure examinations which shall strictly be within the scope of the syllabus or table of specifications of the subject for examination;

WHEREAS, Section 13 of Republic Act No. 11398, otherwise known as the “Philippine Fisheries Profession Act”, states that all applicants for registration as Fisheries Professional shall be required to undergo and pass a written examination which shall be given by the Professional Regulatory Board of Fisheries;

WHEREAS, the Professional Regulation Commission (PRC) announced that One Thousand Five Hundred Seven (1,507) out of Two Thousand One Hundred Sixty-Five (2,165) examinees successfully passed the Licensure Examination for Fisheries Professionals given by the Board of Fisheries in sixteen (16) testing centers nationwide in October 2025;

WHEREAS, the PRC officially released the results of the October 2025 Fisheries Professional Licensure Examination on October 15, 2025;

WHEREAS, Ms. Leslie Kate Tejero Macaling, a resident of Barangay Atabayán, Tigbauan, Iloilo and the daughter of Mr. Freddie Macaling and Mrs. Jesusa Tejero Macaling, graduated *Magna cum Laude* with a degree of Bachelor of Science in Fisheries from the Iloilo State University of Fisheries Science and Technology (ISUFST)-Main Campus, Barotac Nuevo, Iloilo;

WHEREAS, Ms. Leslie Kate Tejero Macaling placed Top Eight (8) in the October 2025 Fisheries Licensure Examination, garnering an impressive rating of 89.00%;

WHEREAS, Ms. Leslie Kate Tejero Macaling was a scholar of the Bureau of Fisheries and Aquatic Resources (BFAR) Region VI, and was awarded as Fisheries Technologist of the Year, Researcher of the Year, recipient of the College of Fisheries and Aquatic Sciences (CFAS) Exemplary Leadership Award, and recognized as Best Student Research Presenter;

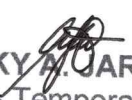
