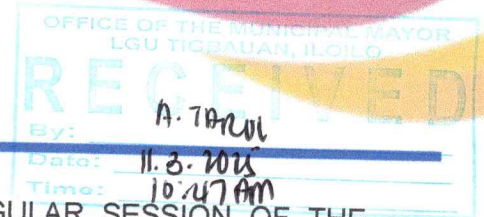




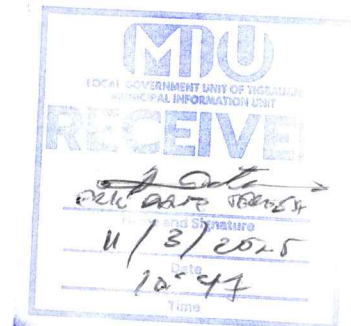

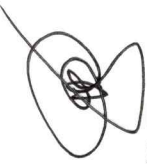
RESOLUTION TEMPORARILY AMENDING RULE VII, SECTION 14(a) OF RESOLUTION NO. 2025-087 OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE (IRP) OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE REGULAR SESSION FROM NOVEMBER 5, 2025, 9:00 O'CLOCK IN THE MORNING TO NOVEMBER 3, 2025 AT 9:00 O'CLOCK IN THE MORNING.

WHEREAS, Rule VII, Sec. 14 (a) of IRP provides:

"RULE VII – REGULAR AND SPECIAL SESSIONS

Section 14. REGULAR SESSION

(a.) The regular session shall be held every **Wednesday** and shall **start promptly at 9:00 in the morning**. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day;
