RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT FINANCIAL ASSISTANCE/INCENTIVES IN THE AMOUNT OF TWO HUNDRED FORTY FIVE THOUSAND PESOS (P245,000.00) TO FORTY NINE (49) ACCREDITED DAY CARE WORKERS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, CHARGEABLE AGAINST MSWDO-INCENTIVES OF DAY CARE WORKERS

WHEREAS, Section 5 of Republic Act 6972 otherwise known as the “Barangay Level Total Development and Protection of Children Act” provides for the role of the Department of Social Welfare and Development (DSWD) in the formulation of the criteria for the selection, qualifications, and training accreditation of Barangay Day Care Workers and the standards for the implementation of the total development and protection of children program;

WHEREAS, Day Care Workers and Early Childhood Development Workers are the forefront of the municipality’s effort in ensuring that all children in the municipality are provided with adequate care, protection and education in their formative years;

WHEREAS, the Municipality of Tigbauan has forty-nine (49) accredited Day Care Workers who have complied with the standards set forth by the DSWD;

WHEREAS, the Local Government Unit of Tigbauan recognizes the critical role provided by the Day Care Workers in nurturing, protecting and educating children in this municipality, thus it is deemed fit and proper to promote and improve their social well-being and economic welfare by providing them financial assistance and/or incentives;

WHEREAS, the Local Government of Tigbauan, through the Municipal Social Welfare and Development Office (MSWDO) has allocated an amount of Two Hundred Forty Five Thousand Pesos (P245,000.00) for the grant of said incentives to forty nine (49) accredited Day Care Workers in the municipality, chargeable against the MSWDO-Incentives of Day Care Workers;
