



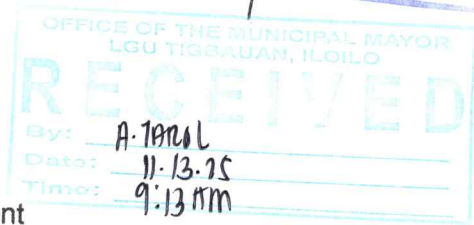

RESOLUTION CONFORMING AND ADOPTING MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (MDC-EXECOM) RESOLUTION NO. 2025-08, DATED NOVEMBER 3, 2025 ENTITLED: "RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) CY 2025 IN THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00) FOR THE REPROGRAMMING OF VARIOUS PROJECTS CY 2025-20% DEVELOPMENT FUND- ECONOMIC DEVELOPMENT PROGRAM OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO"

WHEREAS, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "each local government unit shall have a Local Development Council (LDC) at the provincial, city, municipal, or barangay level which shall assist the corresponding Sanggunian in setting the direction of economic and social development and in coordinating development efforts within its territorial jurisdiction";

WHEREAS, pursuant to Section 287 of the same Code, twenty percent (20%) of the annual Internal Revenue Allotment (IRA) of each local government unit shall be appropriated for development projects as determined by the local development council;

WHEREAS, the Municipal Development Council–Executive Committee (MDC-EXECOM), in its meeting held on November 3, 2025, approved MDC-EXECOM Resolution No. 2025-08, approving the Supplemental Annual Investment Program (AIP) for CY 2025 in the amount of Four Million Pesos (P4,000,000.00) for the reprogramming of various projects under the CY 2025- 20% Development Fund- Economic Development Program of the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, in a letter dated November 3, 2025, the Local Chief Executive, Atty. Virgilio T. Teruel, respectfully requested the Sangguniang Bayan for the passage of a corresponding resolution conforming and adopting said MDC-EXECOM Resolution;

WHEREAS, the Local Finance Committee Members namely: Ms. Elma G. Tionsay, *Municipal Treasurer*, Mr. Jimmy T. Tupas, *MPDC*, Atty. Myra Gene G. Gautier, *Municipal Budget Officer* and Mrs. Mary Grace M. Trio, *Municipal Accountant*, certify that as per records, the amount of **Four Million Pesos (P4,000,000.00)** is available for Supplemental Annual Investment Program for the year 2025, chargeable against the Economic Sector-20% Development Fund to wit: Concreting of

11-14-2025

Farm-to-Market Road (Barosong)- ₱2,600,000.00; Concreting of Farm-to-Market Road (Cordova Norte)- ₱1,000,000.00; and Concreting of Farm-to-Market Road (Sipitan)- ₱400,000.00;

WHEREAS, the passage and adoption of said MDC-EXECOM Resolution is a requisite for the enactment of the corresponding Appropriation Ordinance for the CY 2025 Supplemental Budget;

WHEREAS, the proposed investment programs and activities outlined in the CY 2025 Supplemental AIP are necessary to support priority programs, projects, and services of the Municipality. A copy of the CY 2025 Supplemental Annual Investment Program (AIP) prepared by Mr. Jimmy T. Tupas, MPDC and Atty. Myra Gene G. Gautier, *Municipal Budget Officer* and attested by Atty. Virgilio T. Teruel, *Municipal Mayor* is attached hereto and made an integral part of this Resolution;
