RESOLUTION REQUESTING HONORABLE ARTHUR G. DEFENSOR JR, GOVERNOR, PROVINCE OF ILOILO FOR THE REPAIR/MAINTENANCE OF FARM TO MARKET ROADS LOCATED IN DIFFERENT BARANGAYS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, as stated in the Local Government Code, Section 447. Powers, Duties, Functions and Compensation. (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall: (1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:

(iv) Adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, the aftermath of natural calamities severely affects the condition of the farm to market roads (unconcreted roads) that poses high risk to our constituents;

WHEREAS, the Local Government Unit of Tigbauan lacks sufficient funding to be able to implement the repair and maintenance of all the affected farm to market roads in our locality;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructures and General Services and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Florence Joy V. Cabalonga;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to Request Honorable Arthur G. Defensor Jr, Governor, Province of Iloilo For The Repair/Maintenance Of The Farm To Market Roads Located In Different Barangays Of The Municipality Of Tigbauan, Province Of Iloilo."
