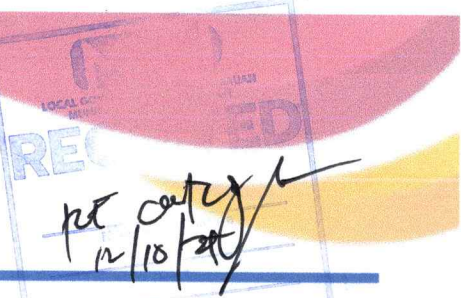




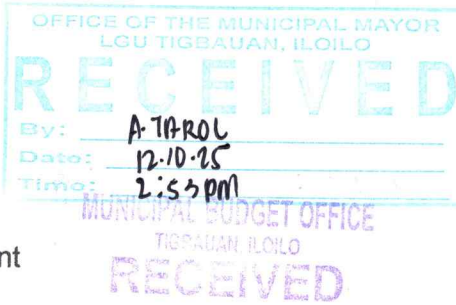

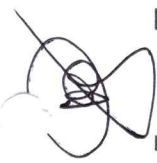

 RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BARANGAY PEACEKEEPING FORCES (BARANGAY TANODS) IN THE MUNICIPALITY OF TIGBAUAN IN RECOGNITION OF THEIR VALUABLE SERVICE TO THE COMMUNITY, THUS WORTHY TO RECEIVE REWARDS/INCENTIVES IN THE AMOUNT OF ONE THOUSAND PESOS (PHP 1,000.00) FOR EACH TANOD (SERVICE OF AT LEAST SIX (6) MONTHS; ₱500.00 IF LESS THAN 6 MONTHS), AND ONE THOUSAND FIVE HUNDRED PESOS (PHP 1,500.00) FOR EACH TANOD COMMANDER CHARGEABLE AGAINST THE BUDGET UNDER EXECUTIVE-DONATIONS

 WHEREAS, in a letter dated December 2, 2025, the Local Chief Executive respectfully requested for the URGENT passing of the aforesaid resolution;

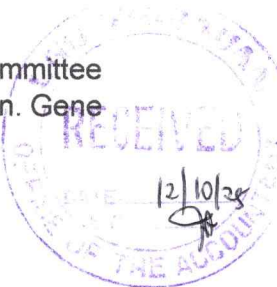
WHEREAS, the maintenance of peace and order in the municipality is among the top priorities of the present administration;

WHEREAS, Barangay Tanods are responsible for maintaining peace and order in their respective barangays, and are often the first to respond to emergencies, public disorders, and disasters, thus worthy to receive rewards/incentives;

WHEREAS, the amount, although minimal, may uplift their moral and eagerness to perform better in their duties and responsibilities in their respective barangays;

WHEREAS, the amount of financial assistance to the Barangay Tanods shall be in the amount of ₱1,000.00 for those who are in service for at least six (6) months, ₱500.00 for those who are in service for less than six (6) months, and ₱1,500.00 for the Tanod Commanders, and shall be charged against the budget under the Executive-Donations;
