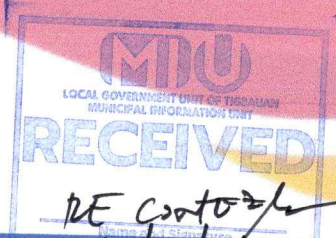




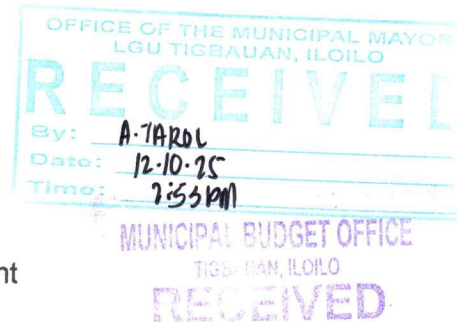

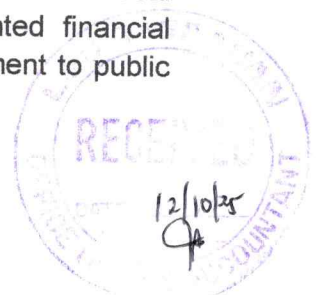
RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT FINANCIAL INCENTIVES AS DONATIONS TO THE TIGBAUAN MUNICIPAL POLICE STATION PERSONNEL, BUREAU OF FIRE PROTECTION-TIGBAUAN PERSONNEL, PHILIPPINE COAST GUARD TIGBAUAN-SUBSTATION PERSONNEL, RESPONDER VOLUNTEERS AND SELECTED HEADS OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) EACH FOR THEIR CONTRIBUTION ON THE MAINTENANCE OF THE PUBLIC SAFETY AND PEACE AND ORDER IN THE MUNICIPALITY FOR THE YEAR 2025, WHILE OTHER NATIONAL AND PROVINCIAL EMPLOYEES IN THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) EACH FOR THEIR ACTIVE SUPPORT TO LOCAL GOVERNMENT PROGRAMS CHARGEABLE AGAINST THE BUDGET UNDER EXEC-DONATIONS

WHEREAS, in a letter dated December 2, 2025, the Local Chief Executive, Atty. Virgilio T. Teruel, requested this Sangguniang Bayan, for the urgent passage of the aforementioned resolution;

WHEREAS, Section 3(k) of the Local Government Code provides that *"The realization of local autonomy shall be facilitated through improved coordination of national government policies and programs, and an extension of adequate technical and material assistance to less developed and deserving local government units";*

WHEREAS, Section 3(l) of the same Code provides that *"The participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development";*

WHEREAS, the Local Government Unit of Tigbauan recognizes the significant contributions of personnel from these various sectors; thus, it is just and proper that employees of national and provincial government agencies, responders and volunteers, members of local councils, and selected heads of Civil Society Organizations (CSOs) be granted financial incentives and awards for their exemplary performance and unwavering commitment to public service in the Municipality;



WHEREAS, granting said financial awards and incentives will encourage efficiency, responsiveness, cooperation, and sustained enthusiasm in the discharge of duties and functions among the different stakeholders of the municipality;

WHEREAS, the Local Chief Executive is empowered to augment funds for the subject expenditures duly appropriated under the Budget for EXEC-Donations;

NOW THEREFORE, on motion of HON. NORA ROSE T. TUBIANO, Chairperson, Committee on Appropriations, Budget, Finance & Accounts and Ways & Means, and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Tigbauan to Authorize Atty. Virgilio T. Teruel, Municipal Mayor, to grant Financial Incentives as Donations to the Tigbauan Municipal Police Station Personnel, Bureau of Fire Protection-Tigbauan Personnel, Philippine Coast Guard Tigbauan-Substation Personnel, Responder Volunteers and selected heads of Civil Society Organizations (CSOs) in the amount of Two Thousand Pesos (₱2,000.00) each for their contribution on the maintenance of the Public Safety and Peace and Order in the municipality for the Year 2025, while other National and Provincial Employees in the amount of One Thousand Pesos (₱1,000.00) each for their active support to Local Government Programs chargeable against the budget under Exec-Donations,
