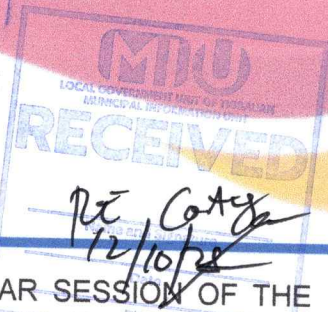




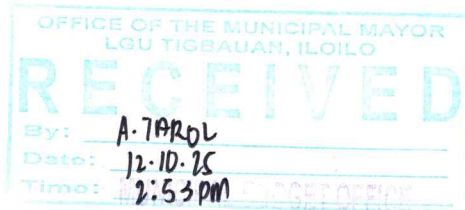

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO GRANT REWARDS AND/OR INCENTIVES IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) IN CONNECTION WITH THE SEARCH FOR THE MOST SENIOR CITIZEN FRIENDLY BARANGAY IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, CHARGEABLE AGAINST THE SENIOR CITIZEN-MSWD FUND

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code, empowers local government units to adopt measures that promote the welfare of their inhabitants, including programs designed to improve the quality of life of senior citizens;

WHEREAS, Republic Act No. 9994 or the Expanded Senior Citizens Act of 2010 mandates local government units to support and implement programs that enhance the welfare, participation, and protection of senior citizens, including initiatives that recognize and strengthen barangay-level efforts;

WHEREAS, the Local Chief Executive, Atty. Virgilio T. Teruel, through a letter dated December 2, 2025, requested the urgent passage of the aforementioned resolution, involving an amount of Thirty Thousand Pesos (P30,000.00), which shall be charged against the Senior Citizen- MSWD funds;

WHEREAS, the Sangguniang Bayan acknowledges that granting such incentives fosters healthy competition among barangays and motivates them to continue enhancing services and programs for the elderly, thereby ensuring the timely recognition of barangays implementing outstanding senior citizen welfare initiatives;
