

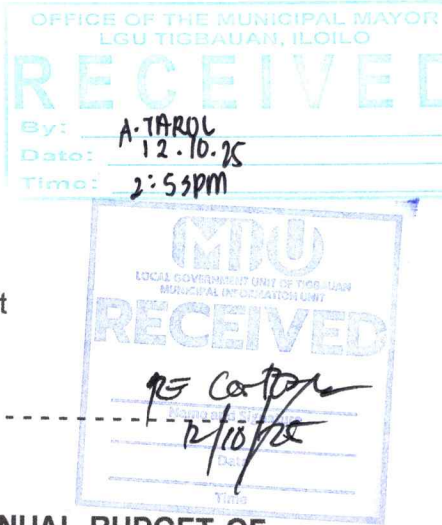

RESOLUTION CONFORMING AND APPROVING THE CY 2025 SK ANNUAL BUDGET OF BARANGAY ALUPIDIAN AND BARANGAY OLO BARROC, MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on November 24, 2025, the Municipal Budget Officer of Tigbauan, Iloilo, endorsed to the Sangguniang Bayan the Calendar Year (CY) 2025 SK Annual Budget of Barangays Alupidian and Olo Barroc, this municipality, as duly approved by their respective Sangguniang Kabataan, for review and appropriate legislative action;

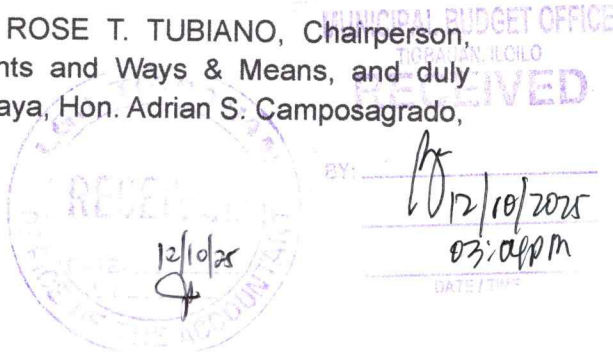
WHEREAS, the SK Annual Budget of Barangay Alupidian in the amount of Two Hundred Fifty Four Thousand Pesos (₱254,000.00) shall be utilized for the following programs: 1) General Administrative Program in the amount of One Hundred Sixty Five Thousand Pesos (₱165,000.00); and 2) SK Development and Empowerment Program in the amount of Eighty Nine Thousand Pesos (₱89,000.00);

WHEREAS, the SK Annual Budget of Barangay Olo Barroc in the amount of Two Hundred Sixty Five Thousand Six Hundred Pesos (₱265,600.00) shall be utilized for the following programs: 1) General Administrative Program in the amount of One Hundred Sixty Seven Thousand One Hundred Pesos (₱167,100.00); and 2) SK Development and Empowerment Program in the amount of Ninety Eight Thousand Five Hundred Pesos (₱98,500.00);

WHEREAS, the Municipal Budget Officer, after review, found the said SK budgets to be compliant with the provisions of the Local Government Code of 1991 (RA 7160) and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the duty of the concerned barangays and SK officials to ensure the lawful, efficient, and proper implementation of the approved budget in accordance with existing laws and regulations;
