

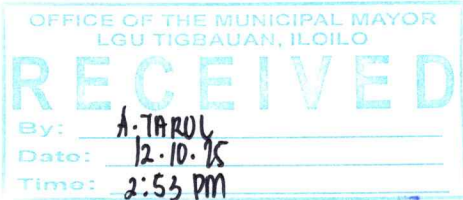

Resolution No. 2025-183

RESOLUTION CONFORMING AND APPROVING THE CONDUCT OF S.B. MARATHON SESSION FOR THE MONTH OF DECEMBER 2025, TEMPORARILY TRANSFERRING THE SCHEDULE OF THE REGULAR SESSION DATE ON DECEMBER 15, 2025, 9:00 O'CLOCK IN THE MORNING TO COMPLY WITH SEC. 52 (A) OF RA 7160.

WHEREAS, Rule VII, Section 14 of Resolution No. 2025-087 (entitled: "RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO") states, to wit:

RULE VII – REGULAR AND SPECIAL SESSIONS

Section 14. REGULAR SESSION - The minimum number of regular sessions of the Sanggunian shall be "once a week".

(a) The regular session shall be held every Wednesday and shall start promptly at 9:00 in the morning. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.

WHEREAS, December 24, 2025 and December 31, 2025 are declared as Non-Working Holidays;

WHEREAS, the holding of a marathon session on December 15, 2025 other than the scheduled session dates is in accordance with **Section 52 (a) of R.A. 7160**, to hold a minimum total number of 52 regular sessions in a year (based on a minimum number of 1 regular session a week);

WHEREAS, the Office of the Sangguniang Bayan is burdened with workloads & paper works before this year ends;

WHEREAS, to promote public service and to ensure attendance of the members of this Sangguniang Bayan in compliance with Sec. 52 (a) of RA 7160, it is imperative that the session date of one of its regular sessions be transferred on December 15, 2025;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, S.B. Committee on Rules, Ordinances, Resolutions and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie Julaton;

RESOLVED, to conform and approve the Conduct of S.B. Marathon Sessions for the Month of December 2023 and Temporarily Transferring the schedule of the Regular Session Date on December 15, 2025, 9:00 o'clock in the morning to Comply with Sec. 52 (A) of RA 7160;
