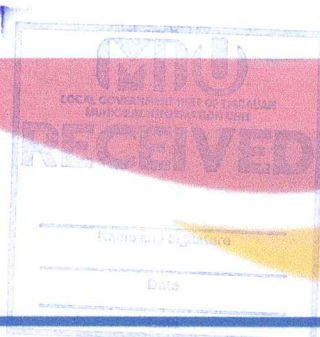

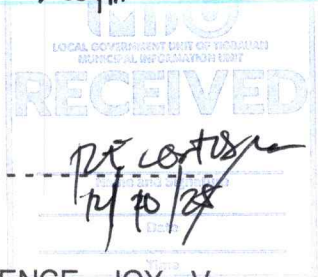
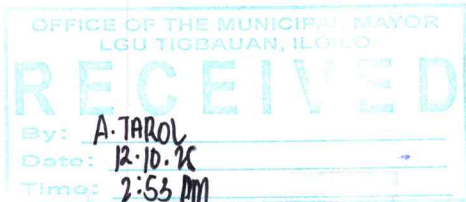

- “AN ORDINANCE ADOPTING MUNICIPAL YOUTH DEVELOPMENT CODE IN THE MUNICIPALITY OF TIGBAUN, ILOILO AND FOR OTHER PURPOSES AND PROVIDING FUNDS THEREOF”;
- “AN ORDINANCE INSTITUTIONALIZING THE LOCAL EXCELLENCE IN GOVERNANCE AND ACCOUNTABILITY OF THE COUNCIL FOR THE YOUTH (LEGACY) AWARDS FOR THE SANGGUNIANG KABATAAN IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING FUNDS THEREOF”
