

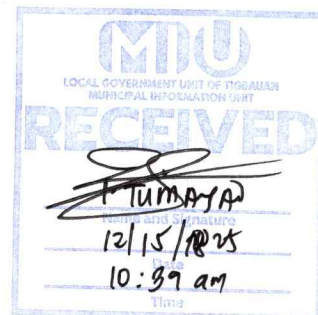

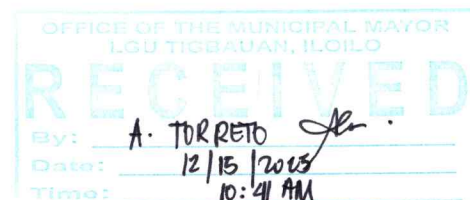
WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Mr. Ramon T. Ledesma has served with utmost dedication and commitment as Head of the Office of Senior Citizen's Affairs (OSCA) of the Municipality of Tigbauan from September 2022 to December 2025;

WHEREAS, during his tenure, he consistently demonstrated exemplary leadership, compassion, and professionalism in advancing the welfare of senior citizens in the Municipality;

WHEREAS, his efforts have significantly contributed to the effective implementation of programs, activities, and services for the elderly sector;
