

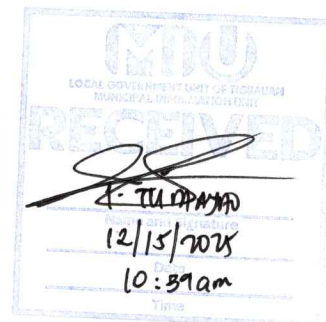

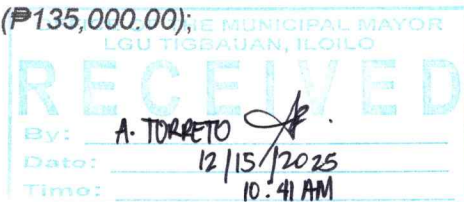
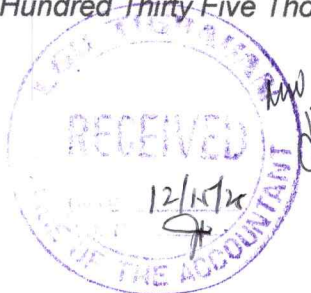
RESOLUTION CONFORMING AND APPROVING THE CY 2025 SK ANNUAL BUDGET OF BARANGAY BAYUCO, BARANGAY BINALIUAN MAYOR AND BARANGAY BUENAVISTA, MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on December 2, 2025, the Municipal Budget Officer of Tigbauan, Iloilo, endorsed to the Sangguniang Bayan the Calendar Year (CY) 2025 SK Annual Budget of Barangays Bayuco, Binaliuan Mayor and Buenavista, this municipality, as duly approved by their respective Sangguniang Kabataan, for review and appropriate legislative action;

WHEREAS, the SK Annual Budget of Barangay Bayuco in the amount of Two Hundred Seventy Five Thousand Pesos (P275,000.00) shall be utilized for the following programs: 1) General Administrative Program in the amount of One Hundred Ninety Eight Thousand Pesos (P198,000.00); and 2) SK Development and Empowerment Program in the amount of Seventy Seven Thousand Pesos (P77,000.00);

WHEREAS, the SK Annual Budget of Barangay Binaliuan Mayor in the amount of Three Hundred Seventy Eight Thousand Pesos (P378,000.00) shall be utilized for the following programs: 1) General Administrative Program in the amount of Two Hundred Eighteen Thousand Pesos (P218,000.00); and 2) SK Development and Empowerment Program in the amount of One Hundred Sixty Thousand Pesos (P160,000.00);

WHEREAS, the SK Annual Budget of Barangay Buenavista in the amount of Two Hundred Ninety Two Thousand Five Hundred Pesos (P292,500.00) shall be utilized for the following programs: 1) General Administrative Program in the amount of One Hundred Fifty Seven Thousand Five Hundred Pesos (P157,500.00); and 2) SK Development and Empowerment Program in the amount of One Hundred Thirty Five Thousand Pesos (P135,000.00);



WHEREAS, the Municipal Budget Officer, after review, found the said SK budgets to be compliant with the provisions of the Local Government Code of 1991 (RA 7160) and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the duty of the concerned barangays and SK officials to ensure the lawful, efficient, and proper implementation of the approved budget in accordance with existing laws and regulations;

NOW THEREFORE, on motion of HON. NORA ROSE T. TUBIANO, Chairperson, Committee on Appropriations, Budget, Finance and Accounts and Ways and Means, and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Tigbauan, to conform with and approve the CY 2025 SK Annual Budget of Barangay Bayuco, Barangay Binaliuhan Mayor and Barangay Buenavista, this municipality;
