RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, TO GRANT FINANCIAL ASSISTANCE TO THE FIFTY-THREE (53) BARANGAY PUBLIC EMPLOYMENT SERVICE OFFICERS (BPESOs) OF THE MUNICIPALITY OF TIGBAUAN IN THE AMOUNT OF TWO THOUSAND PESOS (₱2,000.00) EACH, AMOUNTING TO ONE HUNDRED SIX THOUSAND PESOS (₱106,000.00) IN RECOGNITION OF THEIR VALUABLE SERVICE TO THE COMMUNITY, CHARGEABLE AGAINST ASSISTANCE/INCENTIVES AND UNIFORMS TO BARANGAY PESO MANAGERS, SUBJECT TO EXISTING ACCOUNTING AND AUDITING RULES AND REGULATIONS

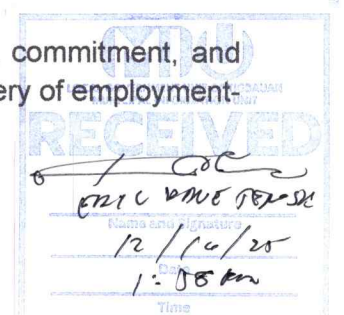
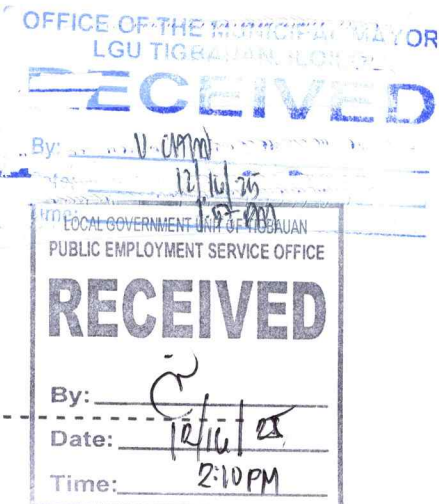
WHEREAS, in a letter dated December 10, 2025, the Local Chief Executive, Atty. Virgilio T. Teruel, respectfully requested for the URGENT passage of the aforesaid resolution;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to promote the general welfare of their constituents, including the enhancement of economic well-being and employment opportunities;

WHEREAS, Republic Act No. 8759, otherwise known as the Public Employment Service Office (PESO) Act of 1999, institutionalized the establishment of PESOs and recognizes the important role of employment service officers in facilitating employment, livelihood, and manpower development programs;

WHEREAS, the Barangay Public Employment Service Officers (BPESOs) play a vital role in implementing employment facilitation programs at the barangay level, including job matching, labor market information dissemination, and coordination with the Public Employment Service Office (PESO), thereby contributing to local economic development;

WHEREAS, the Municipality of Tigbauan recognizes the dedication, commitment, and valuable service rendered by the fifty-three (53) BPESOs in the effective delivery of employment-related services to the constituents,



WHEREAS, it is fitting and proper to extend financial assistance as a form of recognition and support to the BPESOs for their continued service to the community;

WHEREAS, funds are available for the purpose, chargeable against the budgetary allocation for Assistance/Incentives and Uniforms to Barangay PESO Managers, subject to existing accounting and auditing rules and regulations;

NOW THEREFORE, on motion of HON. NORA ROSE T. TUBIANO, Chairperson, Committee on Appropriations, Budget, Finance and Accounts and Ways and Means, and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Tigbauan, to Authorize the Municipal Mayor, Atty. Virgilio T. Teruel, to grant Financial Assistance to the Fifty-Three (53) Barangay Public Employment Service Officers (BPESOs) of the Municipality of Tigbauan in the amount of Two Thousand Pesos (₱2,000.00) each, amounting to One Hundred Six Thousand Pesos (₱106,000.00) in recognition of their valuable service to the community, chargeable against Assistance/Incentives and Uniforms to Barangay Peso Managers, subject to existing accounting and auditing rules and regulations;
