**RESOLUTION CONFORMING AND APPROVING THE CY 2025 SK ANNUAL BUDGET OF
BARANGAY DAPDAP, MUNICIPALITY OF TIGBAUAN, ILOILO**

WHEREAS, on December 4, 2025, the Municipal Budget Officer of Tigbauan, Iloilo, endorsed to the Sangguniang Bayan the Calendar Year (CY) 2025 SK Annual Budget of Barangay Dapdap, this municipality, as duly approved by their Sangguniang Kabataan, for review and appropriate legislative action;

WHEREAS, the SK Annual Budget of Barangay Dapdap in the amount of Two Hundred Ninety Six Thousand Five Hundred Pesos (₱296,500.00) shall be utilized for the following programs: 1) *General Administrative Program in the amount of One Hundred Sixty Five Thousand Five Hundred Pesos (₱165,500.00); and 2) SK Development and Empowerment Program in the amount of One Hundred Thirty One Thousand Pesos (₱131,000.00);*

WHEREAS, the Municipal Budget Officer, after review, found the said SK budget to be compliant with the provisions of the Local Government Code of 1991 (RA 7160) and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the duty of the concerned barangay and SK officials to ensure the lawful, efficient, and proper implementation of the approved budget in accordance with existing laws and regulations;
