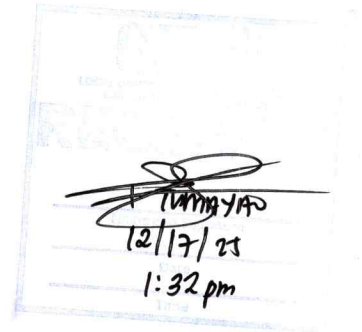

RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY NAPNAPAN SUR ORDINANCE NUMBER NO. 2025-002 "AN ORDINANCE DECLARING EVERY 17TH DAY OF OCTOBER AND THEREAFTER OF EVERY YEAR AS "BADAL DAY" IN HONOR OF THE LATE ATTY. DOMINGO "BADAL" TROMPETA, JR. IN BARANGAY NAPNAPAN SUR, TIGBAUAN, ILOILO AND PROVIDING FUNDS THEREOF"

WHEREAS, as stated in the Local Government Code Section 447. Powers, Duties, Functions and Compensation. (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

- (1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:
 - (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Sangguniang Barangay of Barangay Napnapan Sur adopted and approved Barangay Ordinance No. 2025-002 on September 1, 2025;

WHEREAS, Barangay Napnapan Sur Ordinance No. 002 was endorsed to Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda MLGOO VI on December 4, 2025;

WHEREAS, on December 10, 2025, the said Barangay Ordinance was referred to the Committee on Rules, Ordinances, and Resolutions for review and recommendations;

WHEREAS, upon review, the committee has found that the said ordinance followed certain prerequisites in the formulation of ordinance and is consistent with the provisions of Section 391 of the Local Government Code, to wit;

SECTION 391. Powers, Duties, and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

(1) Enact ordinances as maybe necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;

(24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton,
