RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT IN CONNECTION WITH THE ESTABLISHMENT OF GREENHOUSE WITH HYDROPONICS FACILITY

WHEREAS, the Local Chief Executive in a letter dated December 16, 2025 requested this August Body for the URGENT passing of the aforementioned Resolution;

WHEREAS, said Memorandum of Agreement shall be made and entered into by and between the following parties:

* *The ILOILO PROVINCIAL GOVERNMENT is the local government unit with the principal address at Provincial Capitol Bldg., Bonifacio Drive, Iloilo City herein represented by the HON. ARTHUR R. DEFENSOR, JR., Governor, Province of Iloilo, herein referred to as (FIRST PARTY); and*

* *MUNICIPALITY OF TIGBAUAN, a local government unit with principal address at Tigbauan, Iloilo herein represented by Municipal Mayor, HON. VIRGILIO T. TERUEL in his capacity as the Municipal Mayor, herein referred to as (SECOND PARTY);*

WHEREAS, the FIRST PARTY has appropriated the amount of Php 1,000,000.00 in accordance with 20% NTA CY 2025 Annual Budget.

WHEREAS, the SECOND PARTY requested for the release of the above mentioned amount to implement the project/program;

WHEREAS, the amount of P1,000,000.00 shall be transferred to the SECOND PARTY for the purpose thereof;

WHEREAS, premises considered, the FIRST PARTY AND SECOND PARTY hereby agree to the following:

1. The FIRST PARTY shall require the SECOND PARTY the submission of fund utilization on the said project upon its completion and submission of report of disbursement of the said fund;
2. The SECOND PARTY shall issue official receipt evidencing the receipt of the amount;
3. The SECOND PARTY shall submit Resolution of the Sanggunian authorizing the Punong Barangay/Municipal/City Mayor to sign the Memorandum of Agreement (MOA) with attached Program of Works (POW);
4. The SECOND PARTY shall construct the project on a lot owned, leased, usufruct by the government.
5. The SECOND PARTY shall implement the project within six (6) months from the release of fund;
6. The SECOND PARTY shall return the excess or unused amount for the project to the FIRST PARTY, if any;
7. The FIRST PARTY shall transfer ownership to the SECOND PARTY without cost pursuant to Section 381 of the Local Government Code;
8. The SECOND PARTY shall be responsible for the repair and maintenance of the project funded by the FIRST PARTY;
9. The SECOND PARTY shall submit and strictly comply with the approved program of works of the said project to applicable Commission on Audit rules and regulations.

NOW, THEREFORE, on motion of Hon. Joel L. Sayson. Chairman, Committee on Agriculture and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Juliana Marie T. Julaton,

RESOLVED, to Authorize Atty. Virgilio T. Teruel, Municipal Mayor, To Sign And Enter Into A Memorandum Of Agreement (MOA) With The Iloilo Provincial Government In Connection With The Establsihment Of Greenhouse With Hydroponics Facility,
