RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY CORDOVA SUR ORDINANCE NUMBER 2025-001, "AN ORDINANCE ENCOURAGING THE COMMERCIAL AND OTHER PRIVATE OR PUBLIC ESTABLISHMENTS OF BARANGAY CORDOVA SUR TO INSTALL CLOSED CIRCUIT TELEVISION (CCTV) SYSTEM OR SURVEILLANCE CAMERA TO SUBMIT AND PRESERVE ANY VIDEO FOOTAGE SURROUNDING A CRIME SCENE, COMPLETELY UN ALTERE, TO PROVIDE AN EASY ACCESS FOR ANY LAW ENFORCEMENT AGENCY"

WHEREAS, as stated in the Local Government Code Section 447. *Powers, Duties, Functions and Compensation.* (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

- (1) *Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:*
 - (i) *Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;*

WHEREAS, the Sangguniang Barangay of Barangay Cordova Sur adopted and approved Barangay Ordinance No. 2025-001 on September 20, 2025;

WHEREAS, the Barangay Cordova Sur Ordinance No. 2025-004 was endorsed to Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda MLGOO VI on December 5, 2025;

WHEREAS, on December 10, 2025, the said Barangay Ordinance was referred to the Committee on Rules, Ordinances, and Resolutions for review and recommendations;

WHEREAS, upon review, the Committee has found that the said ordinance followed certain prerequisites in the formulation of ordinances and is consistent with the provisions of Section 391 of the Local Government Code, to wit;

SECTION 391. Powers, Duties, and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as maybe necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Vice - Chairman, Committee on Rules, Ordinances, and Resolutions (under the sponsorship of Hon. Marlon R. Terunez, Committee Chairman) and duly seconded by Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Joel L. Sayson, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Juliana Marie T. Julaton,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to declare as Legal and Valid Barangay Ordinance No. 2025-001 entitled: "An Ordinance Declaring As Legal And Valid Barangay Cordova Sur Ordinance Number 2025-001, "An Ordinance Encouraging The Commercial And Other Private Or Public Establishments Of Barangay Cordova Sur To Install Closed Circuit Television (CCTV) System Or Surveillance Camera To Submit And Preserve Any Video Footage Surrounding A Crime Scene, Completely Unaltered, To Provide An Easy Access For Any Law Enforcement Agency";
