ADOPTING THE MUNICIPAL PEACE AND ORDER AND PUBLIC SAFETY PLAN [POPS PLAN] FOR 2026-2028 OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, DILG Memorandum Circular No. 2011-024 strengthens the local peace and order councils in tackling peace, order and public safety concerns in their localities, and to RA No. 6075, which mandates the development and establishment of an integrated area/ community public safety plan embracing priorities of action and program thrust for implementation by the local PNP stations;

WHEREAS, every Municipal Peace and Order Council shall formulate a 3-year, term-based, Peace and Order and Public Safety Plan which shall be incorporated in the Comprehensive Development Plan of the local government unit;
