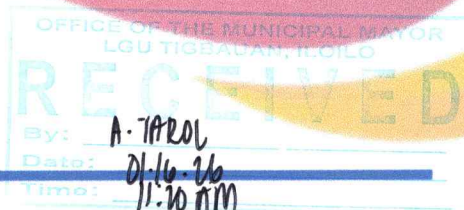




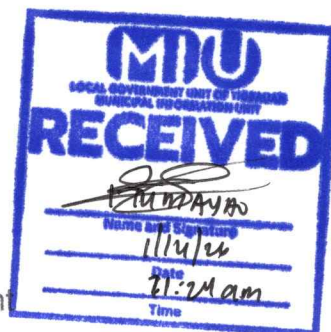

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE 4-H CLUB (RURAL YOUTH) OF THE PHILIPPINES, INC – TIGBAUAN CHAPTER IN CONNECTION WITH THE IMPLEMENTATION OF VARIOUS RURAL YOUTH PROGRAMS, PROJECTS AND ACTIVITIES PROMOTING AGRICULTURAL DEVELOPMENT, FOOD SECURITY AND RURAL YOUTH PARTICIPATION

WHEREAS, in a letter dated January 13, 2026, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of the aforementioned resolution;

WHEREAS, the said Memorandum of Agreement shall be made and entered into by and between the following parties:

- The **Local Government of the Municipality of Tigbauan**, a government office with office address at Tejero St., Tigbauan, Iloilo, represented herein by its Local Chief Executive, **ATTY. VIRGILIO T. TERUEL**, and hereinafter referred to as **LGU TIGBAUAN**; and
- The **FEDERATION OF 4-H CLUB (RURAL YOUTH) OF THE PHILIPPINES, INC. – TIGBAUAN CHAPTER**, a duly organized youth organization, with office address at Tigbauan, Iloilo, Philippines, herein represented by **NIEL T. TENEFANCIA**, Chapter President, hereinafter referred to as **4-H FEDERATION**;

WHEREAS, the Municipality of Tigbauan, with its Municipal Agriculture Office (MAO), is mandated to promote agricultural development, food security, and rural youth participation through training, extension services, and community-based programs;

WHEREAS, the Federation of 4-H Club (Rural Youth) of the Philippines, Inc. is a national youth organization that aims to develop rural youth through programs anchored on Head, Heart, Hands, and Health;

WHEREAS, both PARTIES recognize the vital role of rural youth in agricultural development, leadership, and community service;

WHEREAS, the PARTIES desire to establish a partnership to strengthen agricultural extension, youth capability building, livelihood initiatives, and values formation among 4-H members in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, for and in consideration of the foregoing premises, the PARTIES hereby agree as follows:

ARTICLE 1. OBJECTIVES. LGU TIGBAUAN, with MAO as the lead office, aims to:

1. Strengthen collaboration between the LGU-TIGBAUAN (MAO) and the 4-H FEDERATION in implementing agricultural and youth development programs;
2. Enhance the skills, leadership, and technical knowledge of rural youth in agriculture, fisheries, and allied fields;
3. Promote sustainable agriculture, food production, entrepreneurship, and community involvement among 4-H members; and
4. Support the development of responsible, productive, and service-oriented rural youth leaders.

ARTICLE 2. SCOPE OF COOPERATION. The cooperation under this MOA shall include, but is not limited to, the following:

- 
1. Conduct of trainings, seminars, workshops, and demonstrations on agriculture, fisheries, livestock, gardening, agriprenurship, and related activities;
 2. Implementation of 4-H programs, projects, and activities at the municipal and barangay levels;
 3. Joint organization of agricultural fairs, contests, recognition programs, and youth events;
 4. Provision of technical assistance, mentoring, and advisory services; and
 5. Promotion of values formation, leadership development, and community service.

ARTICLE 3. RESPONSIBILITIES OF THE LGU TIGBAUAN. The LGU TIGBAUAN, under MAO, shall:

- 
1. Provide technical assistance, resource persons, and extension support for agricultural and youth development activities;
 2. Assist in planning, coordination, and monitoring of 4-H related programs and projects;
 3. Endorse and support legitimate 4-H activities conducted within the municipality;
 4. Subject to availability of funds and existing laws, provide logistical or material support when possible; and
 5. Recognize outstanding 4-H members, clubs, and accomplishments.

ARTICLE 4. RESPONSIBILITIES OF THE 4-H FEDERATION. The 4-H FEDERATION shall:

1. Actively participate in and support programs and activities initiated under this MOA;
2. Mobilize its officers and members in the implementation of agreed activities;
3. Uphold the principles, values, and objectives of the 4-H movement;
4. Submit reports and documentation of activities conducted in coordination with the MAO; and
5. Ensure proper conduct, discipline, and accountability of its members during activities.

NOW, THEREFORE, on motion of HON. JULIANA MARIE T. JULATON, Chairperson, Committee on Youth and Sports Development (*under the sponsorship of Hon. Joel L. Sayson, Chairman, Committee on Agriculture & Aquatic Resources*) and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Lorna T. Domingo,

RESOLVED, to authorize Atty. Virgilio T. Teruel, Municipal Mayor, For and in behalf of the Municipality of Tigbauan to Sign and Enter into a Memorandum of Agreement (MOA) with the 4-h Club (Rural Youth) of the Philippines, Inc – Tigbauan Chapter in connection with the implementation of various Rural Youth Programs, Projects and Activities Promoting Agricultural Development, Food Security and Rural Youth Participation.
