RESOLUTION CONFORMING AND APPROVING THE CY 2026 ANNUAL BUDGETS OF BARANGAYS 1 POBLACION, 2 POBLACION, 5 POBLACION, BANGKAL, BAROSONG AND NAMOCON, ALL OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on January 6, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2026 Annual Budgets of Barangays 1 Poblacion, 2 Poblacion, 5 Poblacion, Bangkal, Barosong and Namocan, as duly approved by their respective Sangguniang Barangays, for review and appropriate legislative action;

WHEREAS, the Annual Budget of Barangay 1 Poblacion, as approved under Appropriation Ordinance No. 2025-01 dated November 15, 2025, amounts to Three Million Nine Hundred Twenty Thousand Pesos (P3,920,000.00), with the following budget components: 20% Development Fund (P742,070.00), 10% Sangguniang Kabataan Fund (P392,000.00), 5% Barangay Disaster Risk Reduction and Management Fund (P196,000.00) and Gender and Development (GAD) Attribution (P637,644.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay 2 Poblacion, as approved under Appropriation Ordinance No. 2025-01 dated November 15, 2025, amounts to Three Million Five Hundred Eighty Thousand Pesos (P3,580,000.00), with the following budget components: 20% Development Fund (P705,159.00), 10% Sangguniang Kabataan Fund (P358,000.00), 5% Barangay Disaster Risk Reduction and Management Fund (P179,000.00) and Gender and Development (GAD) Attribution (P487,834.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay 5 Poblacion, as approved under Appropriation Ordinance No. 2025-01 dated December 12, 2025, amounts to Two Million Eight Hundred Fifty Five Thousand Pesos (P2,855,000.00), with the following budget components: 20% Development Fund (P556,511.20), 10% Sangguniang Kabataan Fund (P285,500.00), 5% Barangay Disaster Risk Reduction and Management Fund (P142,750.00) and Gender and Development (GAD) Attribution (P338,806.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay Bangkal, as approved under Appropriation Ordinance No. 2025-01 dated December 7, 2025, amounts to Three Million Six Hundred Sixty Thousand Pesos (P3,660,000.00), with the following budget components: 20% Development Fund (P721,229.20), 10% Sangguniang Kabataan Fund (P366,000.00), 5% Barangay Disaster



Risk Reduction and Management Fund (P183,000.00) and Gender and Development (GAD) Attribution (P608,930.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay Barosong, as approved under Appropriation Ordinance No. 2025-01 dated December 15, 2025, amounts to Four Million Two Hundred Sixty Thousand Pesos (P4,260,000.00), with the following budget components: 20% Development Fund (P828,948.60), 10% Sangguniang Kabataan Fund (P426,000.00), 5% Barangay Disaster Risk Reduction and Management Fund (P213,000.00) and Gender and Development (GAD) Attribution (P794,120.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Annual Budget of Barangay Namocon, as approved under Appropriation Ordinance No. 2025-01 dated November 15, 2025, amounts to Five Million Six Hundred Thousand Pesos (P5,600,000.00), with the following budget components: 20% Development Fund (P1,064,726.00), 10% Sangguniang Kabataan Fund (P560,000.00), 5% Barangay Disaster Risk Reduction and Management Fund (P280,000.00) and Gender and Development (GAD) Attribution (P1,124,653.00) intended to finance programs and projects that ensure the effective and efficient delivery of basic services to the barangay constituents;

WHEREAS, the Municipal Budget Officer, after review, found the said barangay budgets to be compliant with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;
