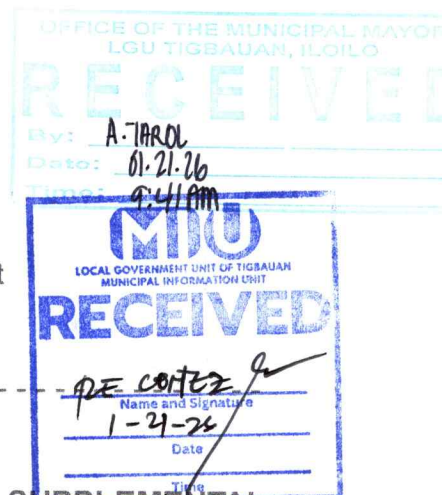
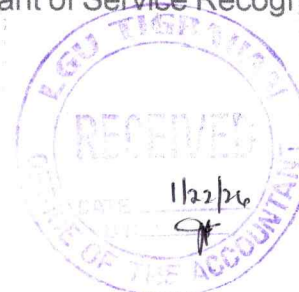
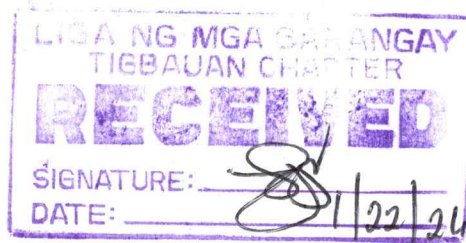
RESOLUTION CONFORMING AND APPROVING THE CY 2025 SUPPLEMENTAL BUDGETS OF BARANGAYS BAYUCO, BARROC, NAGBA, 6 POBLACION, 3 POBLACION, NAMOCON, 9 POBLACION, BANGKAL, BANTUD, PARARA NORTE, PARARA SUR AND CORDOVA NORTE, ALL OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on January 6, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2025 Supplemental Budgets of Barangays Bayuco, Barroc, Nagba, 6 Poblacion, 3 Poblacion, Namocan, 9 Poblacion, Bangkal, Bantud, Parara Norte, Parara Sur and Cordova Norte, as duly approved by their respective Sangguniang Barangays, for review and appropriate legislative action;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-1 of Barangay Bayuco in the amount of SEVENTY-SIX THOUSAND THREE HUNDRED FORTY-FIVE PESOS AND NINETY CENTAVOS (P76,345.90) is intended for the following: Grant of Service Recognition Incentive (SRI)-P61,345.90, Training Expenses- P5,000.00 and Travelling Expenses- P10,000.00, chargeable against the CY 2025 PS Savings (P61,345.90) and CY 2022 Retained Operating Surplus-MOUE (P15,000.00);

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Barroc in the amount of ONE HUNDRED TWENTY-SIX THOUSAND EIGHT HUNDRED SEVENTY-EIGHT PESOS (P126,878.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Nagba in the amount of FIFTEEN THOUSAND EIGHT HUNDRED NINETY-FIVE PESOS AND TWENTY-FIVE CENTAVOS (P15,895.25) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay 3 Poblacion in the amount of SEVEN THOUSAND FIVE HUNDRED ELEVEN PESOS AND NINETY CENTAVOS (P7,511.90) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Bantud in the amount of TWENTY THOUSAND NINE HUNDRED SEVENTY-SEVEN PESOS (P20,977.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-02 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Parara Norte in the amount of ONE HUNDRED SEVENTEEN THOUSAND EIGHT HUNDRED FIFTY-EIGHT PESOS (P117,858.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Parara Sur in the amount of FIVE THOUSAND FIVE HUNDRED PESOS (P5,500.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-02 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Cordova Norte in the amount of THIRTY-NINE THOUSAND SIX HUNDRED PESOS (P39,600.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the Municipal Budget Officer, after due review, found the said barangay supplemental budgets to be compliant with the provisions of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

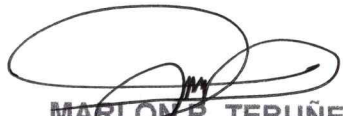
