RESOLUTION CONFORMING AND APPROVING THE CY 2025 SUPPLEMENTAL BUDGETS OF BARANGAYS LUBOG, ALUPIDIAN, TARO, BAROSONG, 1 POBLACION, ATABAYAN, 2 POBLACION, LINOBAYAN AND BITAS, ALL OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on January 9, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2025 Supplemental Budgets of Barangays Lubog, Alupidian, Taro, Barosong, 1 Poblacion, Atabayán, 2 Poblacion, Linobayan and Bitas, as duly approved by their respective Sangguniang Barangays, for review and appropriate legislative action;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Lubog in the amount of FORTY-TWO THOUSAND THREE HUNDRED TWENTY-EIGHT PESOS (₱42,328.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Alupidian in the amount of FIFTEEN THOUSAND THREE HUNDRED FIFTEEN PESOS (₱15,315.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Taro in the amount of FIVE THOUSAND TWO HUNDRED EIGHTY-FOUR PESOS AND NINETY-FIVE CENTAVOS (₱5,284.95) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-02 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Barosong in the amount of FOURTEEN THOUSAND FOUR HUNDRED SEVENTY-SIX PESOS (₱14,476.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-02 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay 1 Poblacion in the amount of ONE HUNDRED FORTY-SIX THOUSAND FIVE HUNDRED EIGHTY-SEVEN PESOS (₱146,587.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Atabayan in the amount of THIRTY-TWO THOUSAND THREE HUNDRED FIFTY PESOS (₱32,350.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-02 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay 2 Poblacion in the amount of TEN THOUSAND EIGHT HUNDRED PESOS (₱10,800.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Linobayan in the amount of EIGHTEEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS AND TWELVE CENTAVOS (₱18,156.12) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Bitas in the amount of SIXTY-SIX THOUSAND EIGHT HUNDRED THIRTY-TWO PESOS (₱66,832.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the Municipal Budget Officer, after due review, found the said barangay supplemental budgets to be compliant with the provisions of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;
