Resolution No. 2026-018

RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY ISIAN ORDINANCE NUMBER 2025-001," AN ORDINANCE FURTHER AMENDING SECTION 3,4, AND 5 OF BARANGAY ORDINANCE NO.2008-01 AS AMENDED BY BARANGAY ORDINANCE NO. 2021-002, OTHERWISE KNOWN AS AN ORDINANCE IMPOSING/CHARGING THE BARANGAY CLEARANCE, BARANGAY CERTIFICATIONS, AND BARANGAY PERMIT FOR THE STORE OWNERS AND ANY BUSINESS OPERATING IN BARANGAY ISIAN, TIGBAUAN ILOILO."

WHEREAS, as stated in the Local Government Code Section 447. Powers, Duties, Functions and Compensation. (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

- (1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:
 - (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Sangguniang Barangay of Barangay Isian adopted and approved Barangay Ordinance No. 2025-001 on October 4, 2025;

WHEREAS, the Barangay Isian Barangay Ordinance No. 2025-001 was endorsed to the Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda MLGOO on January 13, 2026

WHEREAS, on January 14, 2026, the said Barangay Ordinance was referred to the Committee on Rules, Ordinances, and Resolutions for review and recommendations;

WHEREAS, upon review, the committee has found that the said ordinance followed certain prerequisites in the formulation of ordinances and is consistent with the provisions of Section 391 of the Local Government Code, to wit;

"SECTION 391. Powers, Duties, and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (a) Enact ordinances as maybe necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (b) Enact tax revenue ordinances, subject to the limitations imposed in this Code;
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance."

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Rules, Ordinances, and Resolutions and duly seconded by Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton.

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to declare as Legal and Valid Barangay Ordinance No. 2025-001 entitled "AN ORDINANCE FURTHER AMENDING SECTION 3, 4, AND 5 OF BARANGAY ORDINANCE NO.2008-01 AS AMENDED BY BARANGAY ORDINANCE NO. 2021-002, OTHERWISE KNOWN AS AN ORDINANCE IMPOSING/CHARGING THE BARANGAY CLEARANCE, BARANGAY CERTIFICATIONS, AND BARANGAY PERMIT FOR THE STORE OWNERS AND ANY BUSINESS OPERATING IN BARANGAY ISIAN, TIGBAUAN ILOILO."
