Resolution No. 2026-019

RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY ISIAN ORDINANCE NUMBER 2025-002," AN ORDINANCE PRESCRIBING FEES FOR THE FILING OF CASES BEFORE THE BARANGAY LUPON TAGAPAMAYAPA AND FOR OTHER PURPOSES."

WHEREAS, as stated in the Local Government Code Section 447. *Powers, Duties, Functions and Compensation*. (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

- "(1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:
- (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;"

WHEREAS, the Sangguniang Barangay of Barangay Isian adopted and approved Barangay Ordinance No. 2025-002 on October 4, 2025;

WHEREAS, Barangay Isian Barangay Ordinance No. 2025-002 was endorsed to the Sangguniang Bayan of Tigbauan by Mr. Aurelio Ticorda, MLGOO on January 13, 2026;

WHEREAS, on January 14, 2026, the said Barangay Ordinance was referred to the Committee on Rules, Ordinances, and Resolutions for review and recommendations;

WHEREAS, upon review, the committee has found that the said ordinance followed certain prerequisites in the formulation of ordinances and is consistent with the provision of Section 391 of the Local Government Code, to wit;

"Section 391. Powers, Duties, And Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (a) Enact ordinances as maybe necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance."

"Section 410. Procedure for Amicable Settlement. -(a) Who may initiate proceeding - Upon payment of the appropriate filing fee, any individual who has a cause of action against another individual involving any matter within the authority of the lupon may complain, orally or in writing, to the lupon chairman of the barangay."

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to declare as Legal and Valid Barangay Ordinance No. 2025-001 entitled " **AN ORDINANCE PRESCRIBING FEES FOR THE FILING OF CASES BEFORE THE BARANGAY LUPON TAGAPAMAYAPA AND FOR OTHER PURPOSES.**"
