A RESOLUTION ADOPTING PROVINCIAL ORDINANCE NO. 2025-346, AN ORDINANCE INSTITUTIONALIZING THE ILOILO PROVINCE-WIDE HEALTH SYSTEM, INCLUDING ITS MANAGEMENT SUPPORT SYSTEMS, AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, mandates local government units to promote and protect the general welfare of their constituents, including the provision of basic health services;

WHEREAS, access to an efficient, equitable, and integrated health care system is essential to improving the quality of life, productivity, and overall well-being of the people of the Province of Iloilo;

WHEREAS, the Provincial Government of Iloilo enacted **Provincial Ordinance No. 2025-346**, institutionalizing the **Iloilo Province-Wide Health System**, which aims to strengthen health service delivery through a unified, coordinated, and sustainable health care framework among provincial, municipal, and barangay health facilities;

WHEREAS, the said ordinance establishes management support systems, policies, and mechanisms that will enhance governance, financing, human resources, health information systems, and service delivery across the province;

WHEREAS, the institutionalization of a province-wide health system is consistent with national health policies, including the *Universal Health Care Act (RA 11223)*, and supports the devolution of health services to local government units;

WHEREAS, the adoption of Provincial Ordinance No. 2025-346 by the Local Government Unit is necessary to ensure harmonized implementation, effective coordination, and proper allocation of funds for health programs and services at the local level;

WHEREAS, adopting this ordinance will contribute to improved access to quality health care, reduced health disparities, and strengthened resilience of the local health system, especially during public health emergencies;

NOW, THEREFORE, on motion of HON. PINKY A. JARINA, Committee on Health and Sanitation and duly seconded by Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton, **BE IT**

RESOLVED, as it is hereby **RESOLVED**, that the **Sangguniang Bayan of Tigbauan, Iloilo** adopts **Provincial Ordinance No. 2025-346**, entitled *"An Ordinance Institutionalizing the Iloilo Province-Wide Health System, Including Its Management Support Systems, and Appropriating Funds Therefor;"*

RESOLVED, FURTHER, that the concerned offices of the Local Government Unit be directed to support and align their local health programs, plans, and budgetary allocations with the provisions of the said provincial ordinance to ensure its effective implementation;
