**A RESOLUTION ADOPTING THE ILOILO PROVINCE-WIDE HEALTH CARE PROVIDER NETWORK (HCPN) REFERRAL SYSTEM MANUAL, FIRST EDITION 2025.**

**WHEREAS**, the Local Government Code of 1991 (RA 7160) mandates local government units to ensure the delivery of basic and quality health services to their constituents;

**WHEREAS**, the Universal Health Care Act (RA 11223) calls for the establishment of integrated Health Care Provider Networks with standardized referral systems to ensure continuity and efficiency of care;

**WHEREAS**, the Iloilo Province-wide Health System is steadfast in its commitment to establishing a strategic, systematic, efficient and responsive referral mechanism that ensure a seamless continuum of care for every patient in need. Anchored in the principles of accessibility, equity, and timeliness, this system is designed to connect individuals to the right level of care at the right time and in the right place;

**WHEREAS**, this Comprehensive Referral Manual serves as a binding document that encapsulate the collective agreements, commitments, policies, and service profiles of referral facilities within the province. It outlines the capabilities of each facility, providing a clear guide to their roles in the referral process and their capacity to respond to patient needs;
