A RESOLUTION GRANTING AUTHORITY TO HON. ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, ILOILO, TO ENTER INTO AND SIGN A DATA TURNOVER AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) IN CONNECTION WITH THE IMPLEMENTATION OF THE COMMUNITY-BASED MONITORING SYSTEM (CBMS).

 **WHEREAS**, Republic Act No. 11315, otherwise known as the *Community-Based Monitoring System (CBMS) Act*, institutionalizes the CBMS as a tool for poverty alleviation, development planning, and program targeting at the local level;

 **WHEREAS**, the Philippine Statistics Authority (PSA) is mandated to oversee, coordinate, and ensure the proper implementation of the CBMS nationwide;

WHEREAS, the Municipality of Tigbauan has participated in the implementation of the CBMS and has collected community-level data essential for evidence-based planning, policy formulation, and delivery of basic services;

WHEREAS, the PSA requires a Data Turnover Agreement to formally govern the transfer, use, protection, and confidentiality of CBMS data in compliance with existing laws, including the Data Privacy Act of 2012;

WHEREAS, it is necessary to authorize the Municipal Mayor to represent the Municipality of Tigbauan in executing the said agreement to ensure lawful and efficient coordination with the PSA;

NOW, THEREFORE, on motion of Hon. Gene Rose C. Canaya, Chairperson, Committee on Good Government, Justice, Human Rights and Legal Matters and duly seconded by Hon. Pinky A. Jarina, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson, Hon. Marlon R. Teruñez, Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo, and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to grant authority to Hon. Atty. Virgilio T. Teruel, Municipal Mayor, to enter into and sign, for and in behalf of the Municipality of Tigbauan, Iloilo, a Data Turnover Agreement with the Philippine Statistics Authority (PSA) in connection with the Community-Based Monitoring System (CBMS);
