RESOLUTION CONFORMING AND APPROVING THE CY 2025 SUPPLEMENTAL BUDGETS OF BARANGAYS BAGACAY, CANSILAYAN, SIPITAN, DORONG-AN AND TAN PAEL, ALL OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, on January 16, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2025 Supplemental Budgets of Barangays Bagacay, Cansilayan, Sipitan, Dorong-an, as duly approved by their respective Sangguniang Barangays, for review and appropriate legislative action;

WHEREAS, on January 20, 2026, the Municipal Budget Officer of Tigbauan, Iloilo endorsed to the Sangguniang Bayan, the Calendar Year (CY) 2025 Supplemental Budget of Barangay Tan Pael, as duly approved by the Sangguniang Barangay, for review and appropriate legislative action;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Bagacay in the amount of ELEVEN THOUSAND SIX HUNDRED EIGHTY-FIVE PESOS (₱11,685.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Cansilayan in the amount of TWENTY-TWO THOUSAND TWO HUNDRED EIGHTY-TWO PESOS (₱22,282.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Sipitan in the amount of TWENTY-THREE THOUSAND THREE HUNDRED SEVENTY-NINE PESOS (₱23,379.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Dorong-an in the amount of EIGHTY-NINE THOUSAND THREE HUNDRED FORTY-FIVE PESOS (₱89,345.00) is intended

for the following: Grant of Service Recognition Incentive (SRI)- ₱4,345.00, Training Expenses- ₱30,000.00, Travelling Expenses- ₱40,000.00 and Electricity Expense- ₱15,000.00, chargeable against the CY 2025 PS Savings- ₱4,345.00, CY 2023 Retained Operating Surplus (MOOE)- ₱40,000.00 and CY 2024 Retained Operating Surplus (MOOE)- ₱45,000.00;

WHEREAS, the appropriation for Barangay Supplemental Budget No. 2025-01 embodied in Barangay Appropriation Ordinance No. 2025-01 of Barangay Tan Pael in the amount of THIRTY-ONE THOUSAND TWO HUNDRED EIGHTY PESOS (₱31,280.00) is intended for the Grant of Service Recognition Incentive (SRI), chargeable against the CY 2025 PS Savings;

WHEREAS, the Municipal Budget Officer, after due review, found the said barangay supplemental budgets to be compliant with the provisions of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, and its Implementing Rules and Regulations, including all relevant budgeting rules and policies;

WHEREAS, it is the responsibility of the concerned barangay officials to ensure the lawful and proper implementation of the approved budgets in accordance with applicable laws and regulations;
