 RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANETTE LORETA-GARIN THROUGH THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE THE CONSTRUCTION (COMPLETION) OF TIGBAUAN MULTI-PURPOSE BUILDING (ARENA) PHASE 3, TIGBAUAN, ILOILO -(10.682885,122.383108) IN THE AMOUNT OF ONE HUNDRED TWENTY-TWO MILLION PESOS (P122,000,000.00).

 WHEREAS, the Municipality of Tigbauan, Province of Iloilo, is implementing the construction of the Tigbauan Multi-Purpose Building (Arena) as a major public infrastructure intended to support sports development, cultural activities, large public assemblies, and other government-initiated programs;

WHEREAS, the said facility, located in Tigbauan, Iloilo (10.682885, 122.383108), remains incomplete, and the implementation of Phase 3 is necessary to fully operationalize the structure and maximize its intended public use;

WHEREAS, the completion of Phase 3 of the Tigbauan Multi-Purpose Building (Arena) will enhance the Municipality’s capacity to host large-scale events, strengthen youth and sports programs, and provide a suitable venue that may also be utilized during emergencies and disasters;

WHEREAS, the proposed project is consistent with the Municipality’s infrastructure development plans and is aligned with provincial, regional, and national priorities on resilient, inclusive, and people-centered public infrastructure;

WHEREAS, pursuant to Section 17 of Republic Act No. 7160 (Local Government Code of 1991), which mandates local government units to provide basic services and facilities including public infrastructure, there is a need to request financial assistance in the amount of P122,000,000.00 from the Office of Congresswoman Janette Loreta-Garin through the Department of Public Works and Highways (DPWH), and to seek the endorsement and approval of the Provincial Development Council (PDC) and the Regional Development Council (RDC);

NOW, THEREFORE on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Pinky A. Jarina, Hon. Gene Rose C. Canaya, Hon. Adrian S. Camposagrado, Hon. Joel L. Sayson. Hon. Nora Rose T. Tubiano, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Lorna T. Domingo and Hon. Juliana Marie T. Julaton;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance from the Office of Congresswoman Janette Loreto-Garin Through the Office of the Department of Public Works and Highways (DPWH) and Requesting the Provincial Development Council (PDC), Regional Development Council (RDC) to Approve the Construction (Completion) of Tigbauan Multi-Purpose Building (Arena) Phase 3, Tigbauan, Iloilo -(10.682885,122.383108) in the Amount of One Hundred Twenty-Two Million Pesos (P122,000,000.00);
