

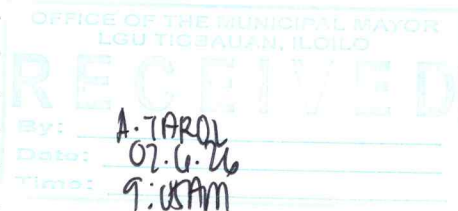

 RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF CONGRESSWOMAN JANET GARIN THROUGH THE OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND REQUESTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), REGIONAL DEVELOPMENT COUNCIL (RDC) TO APPROVE THE CONSTRUCTION OF RIVER CONTROL STRUCTURE ALONG SIBALOM RIVER, STA. 0+745- STA. 1+050, BARANGAY DORONG-AN, TIGBAUAN, ILOILO IN THE AMOUNT OF FORTY-SEVEN MILLION TWO HUNDRED SEVENTY-FIVE THOUSAND PESOS (P47,275,000.00).

WHEREAS, the Municipality of Tigbauan, Province of Iloilo, has been experiencing recurring flooding and riverbank erosion along portions of the Sibalom River in Barangay Dorongan, endangering lives, properties, agricultural areas, and public infrastructure;

WHEREAS, the river section from Sta. 0+745- Sta. 1+050 is highly vulnerable to overflow and erosion during heavy rainfall, necessitating immediate structural intervention to regulate water flow and stabilize riverbanks;

WHEREAS, the proposed construction of a River Control Structure along the said section of the Sibalom River is a critical flood mitigation measure that will reduce disaster risks and protect the affected communities;

WHEREAS, the implementation of the project is consistent with the Municipality's Disaster Risk Reduction and Management Plan and is aligned with national and regional priorities on climate-resilient and sustainable infrastructure;

WHEREAS, pursuant to Section 17 of Republic Act No. 7160 (Local Government Code of 1991), which mandates local government units to ensure the delivery of basic services and facilities, including infrastructure projects for flood control and environmental management, there is a need to request financial assistance in the amount of Forty-Seven Million Two Hundred Seventy-Five Thousand Pesos (P47,275,000.00) from the Office of Congresswoman Janette Loreto-Garin through the Department of Public Works and Highways (DPWH), and to seek the approval of the Provincial Development Council (PDC) and the Regional Development Council (RDC);

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance from the Office of Congresswoman Janette Loreto-Garin Through the Office of the Department of Public Works and Highways (DPWH) and Requesting the Provincial Development Council (PDC), Regional Development Council (RDC) to Approve the Construction of River Control Structure Along Sibalom River, Sta. 0+745- Sta. 1+050, Barangay Dorong-an, Tigbauan, Iloilo in the Amount of Forty-Seven Million Two Hundred Seventy-Five Thousand Pesos (P47,275,000.00);
